# PUBLIC PARTICIPATION SECTION:

- 1 Joseph Mondello Asked the Board to vote in favor of Support Our Troops Block Party scheduled for October 21.
- 2 Ely Fontanez, Pelham Bay resident: asked the Board to review why parking signs were removed near 1910 Pelham Parkway South, at Burr Avenue. Ms. Fontanez added that there is no enforcement for placard abuse.

- 3 Shaniece Heath, TNCAP: November 5, 2018, 6-8 pm, IS 192, 650 Hollywood Avenue, 10465 Town Hall Active Shooter Event.
- 4 Robert Leonardo, Logan Avenue: New owner of Epoxy Bar asked for Board support in approving a new liquor license request.
- 5 Sherrill Cropper, Locust Point resident: Promoted the Farmer's Market on Tuesdays from 4PM to 7PM at Preston High School. The market will run though early November. She thanked the Board for its support. In addition, she reminded the community about the Throggs Neck Merchants Fair on Saturday, September 22, 2018.
- 6 Leslie Brown, NYPL Baychester Branch: Promoted a jazz event on September 21 at 2PM. Citywide, NYPL is actively searching for new applicants for library cards as well as holding citywide voter drives.
- 7 Sergey Shafir, Fedcap, Senior Supervisor: Introduced program that will be financed by Bronx Community Board #10 this fall and winter upon approval by the full Board. Services to be provided are cleanups of trash, graffiti and weed removal at chronic locations throughout the community and snow removal if funding remains.

Mr. Cruz added that each Community Board received funding to be used for OTPS and he is working with Fedcap.

- 8 Leon Tulton, Office of Assemblyman Benedetto: Mr. Tulton is representing the Assemblyman with respect to the SAPO application for the Annual Throggs Neck Halloween Parade on Saturday October 27, 2018.
- 9 Famod Konneh, Bronx Borough Director, Mayor's Community Affairs Office noted the following events and hearings: Property Tax Revisions, Charter Revision, Rikers Island Closing, Animal Shelter. With respect to the Charter Revision, Board members cannot take an official position; however as private citizens, he or she can take a position and encouraged that they should do so.

A discussion among the Board members raised a concern as to losing experienced members and its effect on the Board. R. Baez also addressed the on-going problems at Throggs Neck Houses.

A motion to close the Public Participation Session was made by Mr. Accomando, seconded by Mr. Smith. All were in favor.

The required quorum of twenty-four members for voting on Resolutions could not take place and will be added to the Agenda of the October 18, 2018 Community Board #10 meeting.

#### DISTRICT MANAGER REPORT: Mr. Cruz

Mr. Cruz noted the following topics:

- Casa Lounge incident: Owner and manager met with local elected as well as CB 10; a music video was being filmed at establishment; a copy of the filming contract was given to Mr. Cruz as proof that it was a private event.
- NYC Department of City Planning will meet with its Metro North Working Group in October and November; Mr. Prince and Mr. Cruz will be in attendance.
- The NYC Department of Design and Construction will do a project presentation of the 2019 scheduled water and sewer main project in Pelham Bay.
- George's Restaurant on Buhre Avenue was shut down by the NYC Department of Health for numerous violations.
- Two raccoons in Pelham Bay were identified as carrying distemper; animals should be kept on a leash at all times.
- At the November elections, voting will be done on the City Charter Commission's proposal to limit Board member appointments to four (2) year terms starting in April 2019.
- Throggs Neck Merchants Fair on East Tremont, September 22, 2018, 11:00 a.m. 4:00 p.m.
- 34<sup>th</sup> Annual Veterans Parade will be held on Sunday, November 18, 2018, starting at 12 noon.

A Board member made a suggestion to the Charter Revision with respect to street activity permits and the role of the community board in which the event takes place in that community boards are better equipped to review and approve single day events such as block parties and can better coordinate the notification of needed services by NYPD, FDNY and DSNY.
