

# **BOROUGH PRESIDENT REPORT**: No report

#### **DISTRICT MANAGER'S REPORT**: Mr. Cruz

- Mr. Cruz welcomed all new board members
- Early voting begins next weekend; locations in Bronx CB#10 are St. Francis de Chantal School and Truman High School. Contact the Board Office for times.
- Con Edison gas project in Co-op City on Carver Loop will be extensive. Contact the Board if there are parking issues.

- Starting October 24, 2020 there will be double lane closures for the installation of a beam at the Westchester Avenue/Hutchinson River Parkway.
- There are two gas line inspection projects, DOB LL152 for buildings with 3+ units and a Con Edison project for 1-2 units. Board is trying to get a virtual Town Hall with DOB for information. Mr. Popovic added that there are some companies soliciting inspection services.
- HEAP Home Energy Assistance will be accepting applications in early November, programs runs through March.
- Outdoor dining has been extended to year-round.
- Some November committee meetings have been changed due to holidays: Economic Development will be on Wednesday, November 4; Housing and Zoning will be on Monday, November 9 and Municipal Services will be on Tuesday, November 10. ## YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder

## PARKS/RECREATION COMMITTEE: Mr. Franklin

The Committee did not meet in October. Mr. Franklin noted that funding for NYC Parks has been severely cut, which impacts CB #10. He added that new signage for Pelham Bay Park should be installed in the Spring of 2021.

#### **HEALTH/HUMAN SERVICES:** Bishop Rosario

The Committee will meet on October 22, 2020. No hotspots have been identified in CB10, although there is a rise in COVID19 in 10465. Agenda for the October 22 meeting will include updates from Montefiore/Einstein on COVID19, discussion on a free pediatric dentistry program and updates from the Bronx VA Hospital.

#### **OLD BUSINESS:**

Chairperson Russo noted that the resolution for US Crane on City Island has been tabled pending further information, which is being spearheaded by Ms. Caruso. It will be discussed at a future Housing and Zoning Committee meeting.

Mr. Bieder, who works with the Make-A-Wish Foundation said the organization is looking for volunteer members; Bishop Rosario is on the Board as well.
