## By-Laws \& Membership Committee

Dr. Bruce Rivera, chair of Bronx Community Board Three met with Mr. Vladimir Cruz and Ms. Sarah Torres to discuss following amendments to the By-Laws, in an effort to provide a welcoming and inclusive space for members of the community who are gender neutral.

Following are the suggested amendments:
Article V, Section 3: Any officer elected to fill a vacancy shall hold office for the remainder of the unexpired term and until his successor shall have been elected.

"Any officer elected to fill a vacancy shall hold office for the remainder of the unexpired term and until his-their successor shall have been elected."
Article V, Section 4: An officer may resign at any time by submitting his resignation in writing to the chairperson and district manager.

## Proposing

"An officer may resign at any time by submitting his-their resignation in writing to the chairperson and district manager.
Article V, Section 5: The Chairperson shall preside at all hearings and meetings, file all reports for the Board, be a member of the district service cabinet and the borough board, appoint all committees, be an ex-officio member of all standing and special committees and exercise all those powers granted to him/her by the Charter, the Uniform Land Use Review Procedure and these by-laws.

## Proposing

"The Chairperson shall preside at all hearings and meetings, file all reports for the Board, be a member of the district service cabinet and the borough board, appoint all committees, be an ex-officio member of all standing and special committees and exercise all those powers granted to him/herthem by the Charter, the Uniform Land Use Review Procedure and these by-laws."

Article V, Section 6: The 1st Vice-Chairperson shall have such powers and perform such duties as shall be assigned to him by the chairperson or the Board.

"The $1^{\text {st }}$ Vice-Chairperson shall have such powers and perform such duties as shall be assigned to him them by the chairperson or the Board."

Article V, Section 7: The 2nd Vice-Chairperson shall in the absence of the Chairperson and the 1st Vice-Chairperson have all of the powers and perform all of the duties of the chairperson. Upon the occurrence of a vacancy in the office of chairperson and 1st Vice-Chairperson, the 2nd ViceChairperson shall assume the office of acting chairperson, or, upon the occurrence of a vacancy in the office of acting 1st Vice-Chairperson; in either case, he shall continue to hold office as acting chairperson or acting 1st Vice-Chairperson, until such time as a new chairperson or 1st ViceChairperson shall have been elected and shall have qualified. The 2nd Vice-Chairperson shall have such powers and perform such duties as shall be assigned to him by the chairperson or the Board.

## Proposing

The 2nd Vice-Chairperson shall in the absence of the Chairperson and the 1st Vice-Chairperson have all of the powers and perform all of the duties of the chairperson. Upon the occurrence of a vacancy in the office of chairperson and 1st Vice-Chairperson, the 2nd Vice-Chairperson shall assume the office of acting chairperson, or, upon the occurrence of a vacancy in the office of acting 1st Vice-Chairperson; in either case, he they shall continue to hold office as acting chairperson or acting 1st Vice-Chairperson, until such time as a new chairperson or 1st Vice-Chairperson shall have been elected and shall have qualified. The 2nd Vice-Chairperson shall have such powers and perform such duties as shall be assigned to himthem by the chairperson or the Board."

Article V, Section 8: He/she shall prepare and maintain records showing the attendance of all members at meetings. In addition, he/she shall have such powers and perform such duties as shall be assigned to him by the chairperson or the Board.

In addition, he/she shall have such powers and perform such duties as shall be assigned to him by the chairperson.

Article V, Section 10: In addition, he/she shall have such powers and perform such duties as shall be assigned to him/her by the Chairperson.

Article VII, Section 2: Such request shall set forth his name, the name of any organization he may represent and whether he favors or opposes the proposition which is the subject of the hearing.

## Article VIII: "RECORDS AND COMMUNICATIIONS"

Public Relations and Bind Opinions should be their own articles
Bind Opinions, Section 1: Each member of the Board shall be bound by and act in accordance with any opinion issued by either the Corporation Counsel or the Board of Ethics relating to him/her or to all of the members of the Board.
