A.R.T./New York Theatres with Tony Award-winner Cherry Jones and City and State Officials
on Thursday, December 12, 2013

New York, NY, December 10th, 2013 The Alliance of Resident Theatres/New York, Inc.

[A.R.T./New York], the leading service and advocacy organization for New York City's 375+ nonprofit theatres, will celebrate the *A.R.T./New York Theatres* in a ceremony this Thursday, December 12th at 11am. The event will take place inside the second floor Mezzanine Theatre at 502 West 53rd Street.

The largest and most ambitious project in A.R.T./New York's organizational history, the A.R.T./New York Theatres are specifically designed for New York City's off and off off Broadway theatre companies, which depend on affordable, flexible space to produce work and attract audiences. The complex will include two theatres at the Archstone Clinton development project at 10th Avenue and 53rd Street in Manhattan. The 99- and 150-seat theatres will consist of fully-equipped, highly-flexible performance spaces featuring top quality audio-visual and technical systems. The project will seek LEED Silver status.

The capital campaign in support of the project—The Campaign for the A.R.T./New York
Theatres—is a \$22.5 million project. "We are extremely grateful to the City of New York for
contributing \$14.4 million to the project which will allow us to provide affordable, sustainable
and, accessible performance spaces for our off off Broadway theatres," explained Executive
Director, Ginny Louloudes. Through the Department of Design and Construction's (DDC) *Design Excellence* program, internationally-renowned architect Toshiko Mori and theatrical consultants
ARUP were selected to design the theatre spaces. A.R.T./New York also received \$400,000

from the New York State Assembly for state-of-the-art equipment. A.R.T./New York is now raising the remainder of the monies needed to open the theatres, and create a Building Reserve Fund and a Rental Subsidy Fund.

"The two new theaters within the Archstone Clinton residential development will provide an extraordinary home for A.R.T. / New York's member theatres to produce and present new work on Manhattan's west side," said Department of Cultural Affairs Commissioner Kate D. Levin. "With a cutting edge design by Toshiko Mori and the inspired leadership of Ginny Louloudes and her entire team, this facility is another example of the City's commitment to creating affordable rehearsal and performance space through innovative public-private partnerships."

"We're delighted to celebrate the A.R.T./New York Theatres and offer a 'sneak preview' of the new theatre spaces that will soon be on the way for off and off off Broadway productions, which are the lifeblood of New York's theater community. The terrific design for the new venues, by Toshiko Mori Architects, is a product of our Design and Construction Excellence program, which matches the world's most talented architects to much-needed City projects. We look forward to working with our partners at the Department of Cultural Affairs and A.R.T./New York to build these exciting new spaces for live theater," said David J. Burney, FAIA, Commissioner of the New York City Department of Design and Construction. Cherry Jones will host this special event and will be joined by Commissioner Kate D. Levin; State Assemblymember Linda B. Rosenthal; City Council Member Jimmy Van Bramer; Commissioner David J. Burney; Jeffrey R. Gural, Chairman of Newmark Grubb Knight Frank and the A.R.T./New York Board; actress Daphne Rubin-Vega; and Ms. Mori.

Mr. Gural, one of the city's leading real estate developers, has served as Chairman of the A.R.T./New York Board of Directors since 2009, and earlier this year, he and his wife, Paula, pledged a lead gift of \$1,000,000 to the Campaign for the A.R.T./New York Theatres. Of the project, Mr. Gural commented, "Theatre is what makes New York City's cultural scene what it is, and Paula and I are delighted to support A.R.T./New York, which works at a high level on behalf of all of the city's theatre companies. We have experienced first-hand the passion, commitment, and creativity that our city's artists bring to their work. We are particularly

Manhattan Borough President Scott M. Stringer. "It is so important for our City's small, non-profit companies to be able to showcase their talent in affordable, state-of-the-art theatres."

In 2000 and 2002, A.R.T./New York partnered with the City of New York on groundbreaking new real estate

ventures to create shared office and rehearsal space facilities in Manhattan and Brooklyn.
