

Report to the City Council pursuant to LL 50 of 2011

Reporting Period: Fiscal Year 2016

From: Mayor's Office of Contract Services (MOCS)

Please find the following information on contracts required to be reported under LL 50 of 2011 per the following criteria:

(1) a description of the city's efforts to improve and increase the tracking of information relating to New York state food procured by agencies; MOCS teaches a course to procurement professionals as part of the Procurement Training Institute titled "Legal Compliance in Procurement," which covers the City's guidelines for the purchase of New York state food and teaches agencies how to implement the guidelines. This course was taught three times during Fiscal Year 2016.

(c) the total dollar value of all other food products from outside of New York state and processed food from facilities outside of New York state.
