4. A motion was made to approve the base station license applications recommended for approval. The motion passed unanimously.
5. Item 5, Assistant General Counsel Jason Gonzalez presented on pilot program pursuant to section 52-27(a) of the Commission's rules to test whether more battery electric vehicles ("BEVs"), defined as vehicles that are fully-electric, use rechargeable batteries, and do not use gasoline, can be used safely and efficiently for taxi use (the "BEV Pilot"). Pilot program approval was presented for a vote, and the approval passed unanimously.
6. Item 6, proposing to amend adjudication rules by shortening the timeframe for reviewing summary suspensions based upon pending criminal charges in accordance with a recent federal court decision, *Nnebe v. Daus*. No speakers testified on the matter. Amendments to adjudications rules were presented for a vote, and the rules passed unanimously.
7. Item 7, proposing to amend provisions throughout Title 35 of the Rules of the City of New York to classify the high-volume for-hire service ("HVFHS") license as a type of base license to be regulated separately from black car base licenses. The following people testified on the matter: Avik Kabessa, Carmel; Steven Shanker, The Shanker Law Firm, P.C.

8. Item 8, proposing to amend TLC rules regarding the penalties that govern the way for-hire vehicle bases submit trip records. No speakers testified on the matter.
9. The meeting was adjourned at approximately 11:03 a.m.
