

4. A motion was made to the approve the base station license application recommendations.
The motion passed unanimously.

5. Item 5 on the Agenda, proposing to amend the rule relating to the eligibility criteria for grants under the Medallion Relief Program. A public hearing was held and the following people testified on the matter: Bhairavi Desai, NYTWA; Tamara Vishnyakova; Mouhamadou Aliyu, NYTWA; Richard Chow, NYTWA; Galina Kaminker. Amendments to the rule were presented for a vote, and the rule passed by a unanimous vote. A motion was made to adopt a finding that there existed a substantial need for earlier implementation of the rule, waiving the 30-day promulgation period, and the motion was passed unanimously.
6. Item 6 on the Agenda, proposing a financial disclosure rule that requires that an annual disclosure statement be filed with the TLC by taxicab medallion owners and directors, shareholders, officers, members or partners of a business entity that possesses any interest in a taxicab medallion. The rule was presented for a vote, and the rule passed by a unanimous vote.
