This report uses CD as a proxy for neighborhood. The best indicator of success at neighborhood-based placement is the rate at which children placed in regular foster boarding homes (FBHs) are placed in their home CD. This report focuses on two perspectives: (1) level of care; and (2) sibling groups.
