

**Outcome 3:  
Low Replacements, CD Comparative**

This outcome provides a measure of the foster care system's success at providing stable placements for children while they are in foster care. This report compares these measures for children whose home community district (CD) was the CD of this report in the borough of this report with the same measures for all children from the borough and from the entire city. In the top section of this report the number of children who were in care at least one day in a given month, the number in care at least one day during a calendar year to date and and the number that were transferred during that month or year are enumerated. The next section of the report shows the total number of transfers that occurred in a given month or calendar year and focuses on the following five aspects of these transfers: (1) whether they resulted in a move from one agency to another; (2) whether they were the 1st, 2nd or 3rd or more transfer to occur in a given child's spell<sup>1</sup> in foster care; (3) whether they involved a move to or from a kinship placement; (4) whether they involved a move to or from a child's CD of origin; and (5) whether they affected the intactness of sibling groups in care.
