It focuses on two perspectives: (1) discharges from; and (2) admissions into foster care. The top section focuses on what is perceived to be the best measure of Outcome 4: the rate at which children discharged to reunification return to care within one year. This portion of the report also provides the rate of re-entry based on length of stay at time of discharge, comparing the re-entry rates of those discharged within 90 days of placement to the re-entry rates of those discharged after 90 days of care. The bottom section considers the total number of placements from home (admissions) and provides information on foster care history for those children.
