- 23739: Reconstruction of the West 181st Street Pedestrian Bridge over the Amtrak rail lines as Phase ID of the reconstruction of Riverside Park north of West 135th Street, Fort Washington Park, and Inwood Hill Park west of the Amtrak rail lines, Manhattan. (Preliminary) (CC 7, CB 12) DPR/DOT
