**COMMISSION DIRECTIVE**

Dear Licensees and Registrants:

On New Year's Eve, street access will be restricted in Manhattan, Times Square, and connecting streets from 58<sup>th</sup> Street to 41<sup>st</sup> Street between 8<sup>th</sup> Avenue and Avenue of the Americas to all motor vehicles, including trade waste collection vehicles. The street closures will remain in effect from Thursday, December 31, 2015 through the morning of Friday, January 1, 2016.

**Accordingly, all Licensees and Registrants are hereby directed to complete waste collection and remove their respective containers along the event route before 6:00 a.m. on December 31, 2015.** Collection may resume at 6:00 a.m. on January 1, 2016. Moreover, all Licensees and Registrants must notify all customers along the event route that no waste may be placed on the curbside between 6:00 a.m. December 31, 2015 through 6:00 a.m. January 1, 2016. Business Integrity Commission ("BIC") enforcement agents will be on the event route to ensure compliance with this Directive. 
Please be aware that the City's Department of Transportation ("DOT") issued a holiday construction embargo along the event route from 6:00 a.m. on Monday, November 23 through 11:59 p.m. on Sunday, January 3, 2016. DOT will strictly enforce this embargo and violators are subject to be summonsed.
