Those industries currently include the trade waste industry, the public wholesale markets and the shipboard gambling industry.</p> <p>BIC is seeking a dynamic, experienced lawyer to serve as Executive Agency Counsel. This person will conduct regulatory and background investigations, make regulatory determinations, draft commission decisions and directives, work with the General Counsel to provide a wide range of legal and policy advice and support to the agency, and conduct other legal work related to the agency’s jurisdiction.
