## COMMISSION DIRECTIVE

Dear Licensee or Registrant:

Street access will be restricted in Manhattan along the route of the Macy's Thanksgiving Day Parade. The following streets in Manhattan will be closed to all vehicles beginning the evening of Wednesday, November 26, 2014:

- Columbus Avenue between 81<sup>st</sup> Street and 77<sup>th</sup> Street
- Central Park West between 81<sup>st</sup> Street and 86<sup>th</sup> Street
- 81<sup>st</sup> Street between Central Park West and Columbus Avenue
- 77<sup>th</sup> Street between Central Park West and Columbus Avenue
- 76<sup>th</sup> Street between Central Park West and Columbus Avenue
- 71<sup>st</sup> Street between Central Park West and Columbus Avenue
- Central Park West between 81<sup>st</sup> Street and East Side of Columbus Circle / 59<sup>th</sup> Street
- Broadway between 59<sup>th</sup> Street and 58<sup>th</sup> Street
- 58<sup>th</sup> Street between Broadway and 6<sup>th</sup> Avenue
- 59<sup>th</sup> Street between Columbus Circle and 6<sup>th</sup> Avenue
- 6<sup>th</sup> Avenue between 59<sup>th</sup> Street and 34<sup>th</sup> Street
- 34<sup>th</sup> Street between 6<sup>th</sup> Avenue and 7<sup>th</sup> Avenue
- 33<sup>rd</sup> Street between 6<sup>th</sup> Avenue and 10<sup>th</sup> Avenue
- 34<sup>th</sup> Street between 7<sup>th</sup> Avenue and 8<sup>th</sup> Avenue
- 35<sup>th</sup> Street between 6<sup>th</sup> Avenue and 8<sup>th</sup> Avenue
- 36<sup>th</sup> Street between Broadway and 8<sup>th</sup> Avenue
- 37<sup>th</sup> Street between Broadway and 8<sup>th</sup> Avenue
- 38<sup>th</sup> Street between Broadway and 8<sup>th</sup> Avenue
- 39<sup>th</sup> Street between 7<sup>th</sup> Avenue and 8<sup>th</sup> Avenue
- 40<sup>th</sup> Street between 7<sup>th</sup> Avenue and 8<sup>th</sup> Avenue
- 7<sup>th</sup> Avenue between 33<sup>rd</sup> Street and 40<sup>th</sup> Street
