

- 1.) **PRESENTATION BY NYC DOT: Flushing Avenue Project** - The proposed Flushing Avenue project offers an important east-west bike route connection between the Brooklyn Waterfront Greenway, Downtown Brooklyn, the Manhattan and Brooklyn Bridges with the developing Ridgewood bicycle network . This facility would add 5.1 miles to the existing network and connect with the north-south routes on Classon Ave, Franklin Ave, Bedford Ave, Thompkins Ave., Throop Ave. The design treatment for the corridor consists primarily of shared lanes. Where feasible, bike lanes can be designed, and no parking will be removed.
