Continued Discussion from the March 12, 2013 Public Hearing/Board Meeting regarding Street Cleaning Regulations and Alternate Side Of The Street Parking.** Representatives from the NYC Department of Sanitation & the NYC Police Department are invited to the joint meeting to participate in a discussion with the committee members regarding a policy that the board members have observed in other community board areas. The members have viewed that motorists are allowed a courtesy of cueing/staging of vehicles in the center roadway during alternate side of the street sweeping to allow the mechanical broom to sweep the street.
- 2.) Proposal by the Department of Sanitation to make changes in Alternate-Side Street Cleaning (SCR) regulations from nighttime to days -** Wallabout Street (between Kent/Wythe Aves.), Wythe Avenue (between Rutledge & Wallabout Sts.) Flushing Avenue (between Taaffe Place & Spencer St.), Franklin Avenue between Wallabout Street and Flushing Ave.)
- 3.) Request for changes on ASP/Street Cleaning signs -** ( A.) For Lee Avenue, from Taylor Street to Flushing Avenue: to be changed to 4PM-7PM, and ( B.) Wythe Avenue from Rutledge Street to Wallabout Street, and Wallabout Street from Kent Ave to Franklin Ave.: to be changed from night cleaning designation(for an industrial area) to daytime residential hours.
