DISCUSSION ON PROPOSED NEW SCHOOL** - NYC School Construction Authority - Pursuant to Section 1731 of the New York City School Construction Authority Act, notice has been filed for the proposed site selection of Block 2494, Portion of Lot 1, and any other property in the immediate vicinity which may be necessary for the proposed project, located in the Borough of Brooklyn, for the construction of a new, approximately 640-seat primary/intermediate school facility in Community School District No. 14. The proposed site contains a total of approximately 20,000 square feet of lot area (0.45 acres) and is located on the southwest corner of Franklin and Dupont Streets in the Borough of Brooklyn. The site currently contains a one-story structure used for auto repair and a paved areas for parking
