

Chairman Peter Sullivan began the meeting at 7:00 p.m. with the Pledge of Allegiance.

The above Community Liaisons were introduced and thanked for coming.

#### **PUBLIC PARTICIPATION SECTION:**

- 1 Linda Collins, Pres. Bldg. 9: Ms. Collins commended Mrs. N. Kilkenny of the Bronx CB #10 office for her assistance with constituent problems.
- 2 Gretchen Hazel, 120 Alcott Place: Ms. Hazel addressed the garbage along the highways, traffic medians, in Co-op City.

Mr. Sullivan said this will be addressed by the Board and Ad Hoc Co-op City Committee.

3 – Steven Vega, VP of Bldg. 4 Assn.: Mr. Vega addressed the new LED lights which are inoperative as well as the street conditions throughout Co-op City esp. Carver Loop and Co-op City Blvd, which need re-milling and/or pothole repair.

Mr. Sullivan will ask DOT to survey the area and correct potholes; street lighting – will reach out to DOT for information.

4 – Peggy Diaz, 34A Debs Place: Ms. Diaz has complaints as a cooperative owner with Riverbay.

Mr. Boiko addressed Ms. Diaz concerns which she needs to discuss directly with Riverbay.

5 – Bernice Alexander, 140 Alcott Place: Ms. Alexander has complaints with the Riverbay management and would like to transfer to another apartment. Ms. Alexander also raised concers about the stores coming into the Mall.

Ms. Chambers, CB #10 Board Member suggested that Ms. Alexander become active in her Building Association as well as attending meetings.

6 – Michele Marbury, 120 Bellamy Loop: Ms. Marbury has noted the lack of ADA compliancy throughout Co-op City in that pedestrian access is blocked by vehicles as well as missing signage.

Mr. Boiko noted that signage was originally installed by Riverbay and DOT put up NO STANDING signs. He urged Ms. Marbury to call NYC 311 with complaints, as well as reaching out to Sgt. Lawyer of the 45<sup>th</sup> Precinct.

Ms. Marbury expressed complaints about the #12 Bus in Co-op City, especially by the Mall. She also added that snow removal in Co-op City at the corners and bus stops needs addressing.

Mr. Sullivan said the Board will request a DSNY representative to meet with the Ad Hoc Committee to address this concern.

7 – Egidio Sementilli: Mr. Sementilli supports the resolution before the Board to request a pedestrian operated traffic light at Pelham Bay station. Mr. Sementilli questions the accuracy of the information presented at the Housing and Zoning meeting concerning the residents at Fort Schuyler House; he claims that seniors are being forced to sign on to Section 8 and are not guaranteed a housing voucher.

- 8 Jewel Crawford, 100 Debs Place: Ms. Crawford has several traffic safety issues: At the Pear Tree Mall near the Municipal Credit Union, the street markings need refurbishing and stop signs need to be put in place. Carver Loop needs a traffic study.
- 9 Marie Smith VP Bldg. 29 Assn.: Section 5 needs lighting on the bicycle walkway path which is very dark; shrubbery is overgrown and obstructs view. Section 5 also needs more consistent cleanup along the highway and streets.

Mr. Sullivan said that the lighting along the bicycle has been a project that Mr. Prince has been working on and planning is in the works. He added that Parks will need to readdress the shrubbery. Mr. Misiurski said that the funding for lighting has continually been a part of the Capital and Expense Budget requests. An estimated cost for this project is \$198,000.

10 – Marie Standford, President of Bldg. 29 Assn. Ms. Standford echoed Ms. Marie Smith's comments about the lighting and overgrowth of shrubbery. She added that the streets in Section 5 near Co-op City Boulevard are buckling, especially Asch Loop.

Mr. Cruz advised Ms. Standford that these streets were put in for repairs.

11 – Marlene Smith, 100 Benchley Place: Connor Street into Provost Avenue- needs resurfacing. In addition, the Carver Loop matter will be addressed by DOT.

Mr. Cruz will forward the Connor Street item to CB 12.

12 – Francine Reva Jones, Riverbay Board Director: Ms. Jones wants clean-up along Bartow Avenue done on a regular basis; in addition she added that the areas along the highway need consistent clean-up. Ms. Jones was also concerned about the proposed Baychester Square project, which did not pass through the City Council.

Ms. Cruz said that the Board will contact NYS DOT to discuss the highway clean-up concerns.

The Community Liaisons spoke next.

Mr. Cruz held a moment of silence in honor of A. King Jr., father of Council Member King who recently passed away.

Boiko of Riverbay concerning the maintenance of the jersey barriers along Killer Curve which will be repaired and repainted by the end of October. Mr. Cruz is scheduling meetings with DSNY and State DOT concerning the clean-up of medians, roadways, highways, etc. throughout Co-op City. The refurbishing of street markings in Co-op City is scheduled for January 2018. He is also meeting with NYS Thruway and NYS DOT to address the clean-up at Bartow and Edson Avenues.

On Saturday October 21, 11:00 a.m.-1:00 p.m. a workshop with DCP for property owners living in flood zones will be conducted at SUNY Maritime.

Mrs. D. Lock, a long time Board member recently resigned from the Board. She is relocating to Westchester County.

#### **COMMITTEE REPORTS**

## PLANNING & BUDGET – Mr. Misiurski

On October 4, 2017, a public hearing on the Capital and Expense Budget Requests were held, followed by a Planning and Budget Committee meeting. Each item in the FY 2019 Capital and Expense Budget Priorities was reviewed. One item, Capital #11 will be amended to reflect lighting from Westchester Square to Castle Hill Avenue.

A Floor Resolution was presented to the Board:

"Resolved... at the request of Bronx Community Board 10 that the FY 2019 Capital and Expense Budget Requests, attached, which were prepared and presented by the Planning and Budget Committee of Bronx Community Board 10, be approved."

A motion to accept the Resolution was made by Mr. Cantillo, seconded by Mr. Accomando and was unanimously approved by all. *The Resolution passed*.

## **EXECUTIVE COMMITTEE:** Mr. Sullivan

The Committee did not meet in October and will meet in November.

#### **HOUSING/ZONING COMMITTEE:** Mr. Popovic

The Committee met on October 10, 2017. Minutes are self-explanatory. Mr. Popovic said the Committee had an informative meeting with Deacon Murphy of Fort Schuyler House. He added that the Committee posed good questions and were assured that no resident would lose his or her residency whether or not a voucher was secured.

#### **ECONOMIC DEVELOPMENT COMMITTEE:** Mr. Accomando

The Committee met on October 3, 2017. There were resolutions for renewal, new liquor licenses and change in method of operation licenses.

The Committee met on October 11, 2017. The following resolutions were presented to the full Board:

A motion to accept the Resolution was made by Mrs. Acampora, seconded by Mr. Chirico was unanimously approved. *The Resolution passed*.

"Resolved...at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that the request to remove street markings on East Tremont Avenue pointing towards a turn onto Maclay Avenue be forwarded to DOT after a vote by the full Board"

A motion to accept the Resolution was made by Mr. Cantillo, seconded by Mr. Accomando was approved by a majority of Board members with one recusal due to a conflict of interest. *The Resolution passed.* 

"Resolved...at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that a request to extend no parking on the Home Depot side of Brush Avenue from Bruckner Boulevard to Lafayette Avenue as well as putting in new and refurbrished street markings to delineate vehicles turning from/onto Bruckner Boulevard be forwarded to DOT after a vote by the full Board."

A motion to accept the Resolution was made by Mr. Marano, seconded by Mr. Cantillo was approved by a majority of Board members with one recusal due to a conflict of interest. *The Resolution passed*.

"Resolved...at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that the request for a speed hump on the 600 block of Vincent Avenue be forwarded to DOT after a vote by the full Board."

A motion to accept the Resolution was made by Mr. Sullivan, seconded by Mr. Accomando was approved by a majority of Board members with one recusal due to a conflict of interest. <u>The Resolution passed.</u>

"Resolved...at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that a request to change the existing traffic signal at the intersection of Burr Avenue and Westchester Avenue at Pelham Bay Station, into a pedestrian button-operated one be forwarded to the Bronx Borough Commissioner of DOT after a vote by the full Board."

A motion to accept the Resolution was made by Mr. Chirico, seconded by Mrs. Acampora was approved by a majority of Board members with one recusal due to a conflict of interest. *The Resolution passed.*
