

Chairman Martin Prince began the meeting at 7:00 p.m. with the Pledge of Allegiance.

The above Community Liaisons were introduced and thanked for coming.

A slide show by the NYC Department of Cultural Affairs, Percent for Art presented the conceptual design artwork for the new library at Westchester Square. Staff included Mr. Kendal Henry, Director, NYC Percent Art; Ms. Dora Blount, Public Art Project Coordinator with the NYC Department of Design and Construction and Mr. Steve Torrenti of the New York Public Library.

After the art presentation, Mr. Prince thanked the staff and principal of P.S. 175 for hosting the Board meeting as well as Mr. Scavello and Mr. Carman for the parking arrangements.

PUBLIC PARTICIPATION SECTION:

- 1 K. Crymes, resident of Tiemann Avenue: Ms. Crymes spoke in opposition on the proposed Baychester Plaza Development specifically about traffic on the highways and local roads; she requested that Boards 10 and 11 work together towards a different kind of development.
- 2 L. Rocco, Westchester Square Civic Association: Mr. Rocco addressed numerous issues such as the accident caused by speeding on E. Tremont Avenue near Lurting Avenue, wants more traffic calming and the Slow Zone speed humps were installed but claims that the markings are deficient. He worked with the WSBID in reporting snow removal. Mr. Rocco also noted the ADA noncompliance at libraries and parks. Mr. Rocco wants more jobs for the youth and more schools in the community. He feels that complaints are not taken seriously and wants more community involvement and quality of life issues are not being addressed.

- 4 E. Sementilli, Pelham Bay Safety and Improvement: Mr. Sementilli was in support of all the resolutions which were to be voted on at the March 16, 2017 meeting.
- 5 L. Brown, NYPL, Baychester: Ms. Brown said to check the library's website for programs. She also added that ongoing financial support for all NYPL is needed.
- 6 I. Santos, former Board member and resident of City Island: Ms. Santos asked about the closing of the only pharmacy on the Island. Mr. Cantillo responded that rent became too expensive and the pharmacist and prescriptions have been transferred to the CVS pharmacy at Pelham Bay.
