Meeting began at 7:08 p.m. with the Pledge of Allegiance. A motion from Chairman Prince to go into Executive Session was seconded Mr. Cantillo, and unanimously approved by all in attendance. All public attendees and Board staff left the room. The full Board meeting resumed at 7:15 p.m. It was announced that during the Executive Session, the Board voted on the selection of Mr. Matthew Cruz as District Manager. This vote was repeated in full public view and was unanimous.

The above Community Liaisons were introduced and thanked for coming.

A motion to accept the proposed Agenda for the April 20, 2017 meeting, in which the resolutions from the March 16, 2017 Community Board #10 meeting would be discussed and voted on first was made by Mr. Accomando, seconded by Mr. Russo, and unanimously approved by all in attendance.

A motion to accept the minutes from the February 16, 2017 Bronx Community Board #10 meeting was made by Bishop Rosario, seconded by Mr. Bieder was unanimously approved by all.

A motion to accept the minutes from the March 16, 2017 Bronx Community Board #10 meeting was made by Ms. Lock, seconded by Mr. Boiko was unanimously approved by all.

The Resolutions from the March 16, 2017 full Board meeting, which did not have a quorum, as well as the Resolutions from the April 20, 2017 full Board meeting will be recorded in their respective committee reports starting on page XX.

## **PUBLIC PARTICIPATION SECTION:**

- 1 B. Bieder discussed the upcoming 45<sup>th</sup> Precinct Community Council Breakfast in May and announced the honorees. Flyers are available.
- 2 J. Parson, Senator Jamaal Bailey, District 36 in Co-op City: Upcoming events under Sen. Bailey's sponsorship are Autism Awareness on 4/27/17 and a Mother's Day event on 5/20/17. Contact the office for additional information, 718-547-8854.
- M. Salazar, Montefiore Health System: on 5/13/17 breast cancer screening for underinsured at 3400 Bainbridge Ave; Wakefield Campus 5/20/17 teddy bear hospital under age of 12; new primary care facility to be located on East Tremont Avenue, lease signed, and Montefiore will join the Throgs Neck BID. - 4 B. Jaen, President, Throgs Neck Merchants: June 3, 2017 Merchant's Street Fair, b/t Lafayette and Randall Avenues and at Anthony's Flower Farm, 3240 East Tremont Avenue, 10461; Merchants BID meeting scheduled for 4/26/17. Mr. Jaen spoke in favor of the renewal liquor license for Tosca Café and said the Merchants will work with Tosca and the surrounding community.
- 5 T.McCree and D. Collado, NYPL, City Island and Westchester Square: discussed events in both Libraries scheduled for May 2017.
- 6 E. Sementilli: Mr. Sementilli's concern is the lack of transparency in the Search Committee meetings. He wants the minutes clarified to reflect that he came in to a meeting at 7:18 p.m. He said that there was no transparency in the selection of a new district manager. He also noted that there was a private meeting in the Board Office concerning Seafood City. He requested minutes from the March 27<sup>th</sup> Search Committee meeting.
- 7 J. Grennan, Throgs Neck resident: Ms. Grennan opposes the renewal of Tosca's liquor license and brought up the following problems: Miles Avenue parking, trash pickup schedule and trash blocking the sidewalk, also said that patrons block the sidewalk causing residents to walk in the street; noise issues; feels occupancy is over the allowable requirement.

- 8 T. Takedis, resident of TN: Mr. Takedis spoke in support of the renewal license for Tosca's and informed the community of the good deeds with charitable donations, e.g. Sisters Servants of Mary. He added that Tosca's is very generous with donations.
- 9 A. Ponder, CB 10 Board Member: Informed the community of the upcoming National Action Network National Convention on April 26 – April 29, 2017 at the Sheraton Hotel on 53<sup>rd</sup> Street and 7<sup>th</sup> Avenue.
- 10 L. Rocco: Mr. Rocco complained about two different set of rules that the Board used; stated that he made many changes in his community without the assistance of the community board; and mentioned specifically the handicap ramp at the Westchester Square Public Library that was installed through his effort. He also complained that the ramp needs maintenance and the library has no money to hire an electrician.
- 11 M. Liebman, manager of Tosca's: Tosca's wants to work with the community and will take steps to ensure a better relationship. Tosca's closes at 1:00 a.m., 7 nights a week; the establishment has had audits with DEP to measure decibel levels; trash pickup is between 12 midnight -1 a.m. and a porter cleans up afterwards. The State Liquor Authority permits unlimited brunch cocktails. There is a constant stream of patrons coming to brunch and seating is on a schedule; parking is an issue because of all the businesses in the area. Ms. Liebman will work with the Throgs Neck Merchants.
- 12 V. Ortiz: Mr. Ortiz congratulated the incoming District Manager of Community Board 10. Mr. Ortiz said the search process was not properly addressed and questioned how fourteen applications were looked at is less than twenty minutes. Mr. Ortiz wants to have meetings electronically recorded. He added a concern with the interaction between a board member and the chair and added there was not enough transparency with agenda items.

Board member, Mr. Accomando, addressed the public who expressed concerns over the process of selecting a candidate for the position of district manager as well as the review of the application process. He stressed the experience level of the search committee members, the openness of the meetings and the volunteer efforts of every single board member.

The managers of Seafood City contacted the Board with a request to meet. Mr. Prince noted that NEWS 12 was called by Mr. Sementilli with a request for a filming of the meeting. Mr. Prince added that the meeting was not a public one, nor was it a committee meeting. As a result, Stipulations have been strengthened, the establishment has reached out to the City Island Civic Association (CICA) and will work with the surrounding community and CICA.

Board Member Ponder said that he attended the meeting with Seafood City and supported Mr. Sementilli's concern about a lack of transparency.

Mr. Prince thanked the management of the Villa Barone Restaurant for allowing the Board to hold its April meeting.

## COMMITTEE REPORTS

## **EXECUTIVE COMMITTEE:** Mr. Prince

The Committee met on April 3, 2017 and March 6, 2017. All of the resolutions below were voted on by the full Board at the April 20, 2017 meeting.

Two floor resolutions from the March 6, 2017 meeting were presented.

"**Resolved**...at the request of the Executive Board of Bronx Community Board #10, that the proposed changes to the By-Laws, presented to the full Board for review in February, be approved and signed by the Secretary of the Executive Board of Bronx Community Board #10."

A motion to accept the Resolution was made by Bishop Rosario, seconded by Mr. Bieder and approved as follows: twenty-three (23) in favor, three (3) against and four (4) abstentions. **The Resolution passed**.

"**Resolved...** at the Executive Committee meeting of March 6, 2017, that removal procedures be initiated for members that have failed to meet the attendance requirements for full board/public hearings attendance as per Bronx CB #10 by-laws. Letters of inquiry will be forwarded to members with attendance issues.

A discussion began on the merits of the resolution as to the attendance at both Committee and full Board meetings took place. A motion from Mr. Bieder to table the vote pending further information on this resolution was seconded by Bishop Rosario, with agreement from a majority of members, with one (1) opposed. **The Resolution is being tabled back to the Executive Board.** 

Nominations and Election Procedures were distributed to the Board and resulted in a resolution at the April 3, 2017 meeting as follows:

**"Resolved**... at the recommendation of the Executive Board of Bronx Community Board #10 that the Election/Nominations guidelines prepared and submitted by R. Bieder and A. Ponder be forwarded to the full Board for approval."

A discussion on this Resolution was started by Mr. Barbarelli. He wants a change to eliminate <u>standing</u> <u>committee</u> terminology and change with <u>any committee</u>. Mr. Prince said this was discussed at the Executive Board meeting which voted it down. Ms. Lock added that this information about ad hoc and standing committees is discussed at new member orientations. Ad hoc committees do not count, it is the standing committees that do the actual work. It would have to go back to the By-Laws Committee for discussion.

A motion to remove the word <u>standing</u> Article VII, Section II was made by Mr. Barbarelli and seconded by Dr. Ponder with the following result: twenty-two (22) opposed, five (5) in favor, and three (3) abstentions. The motion did not pass.

A motion to accept the Resolution as written above was made by Mr. Boiko, seconded by Mr. Cantillo and unanimously approved by all members. **The Resolution passed**.

The following resolution was presented as a floor motion at the April full Board meeting:

**"Resolved**...at the recommendation of the Executive Board of Bronx Community #10 that the Board unanimously voted to conduct an orientation meeting for new board #10 appointees prior to the June 2017 full board meeting and that this be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Dr. Hunt and was voted on by a majority of members, with one abstention. **The Resolution passed.** 

The Executive Board also voted on a time sensitive matter due on April 14, 2017 concerning an application for an unenclosed sidewalk café.

**"Resolved**...at the recommendation of Bronx Community Board #10 that the request for an Unenclosed Sidewalk Café, DCA Application #2366-2017-ASWC consisting of 19 tables, 38 chairs

for Pizzaniste Restaurant, 3430 East Tremont Avenue, 10465 be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Ms. Lock and unanimously approved by all members. **The Resolution passed**.

The Executive Board also voted on a time sensitive matter on a Street Activity Permit Application:

**"Resolved**...at the recommendation of Bronx Community Board #10 that the following event id #332577, Movie Nights at Westchester Square, 4/21/17, 5/12/17, 7/21/17, 9/15/17, 10/14/17, from 6PM-9PM with setup and breakdown from 5-9:45PM, on Lane Avenue b/t East Tremont and Westchester Avenues, sponsor is WSBID, be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Accomando and unanimously approved by all members. **The Resolution passed**.

A discussion on the selection of members to serve on the ad hoc committee for Nominations began. Dr. Ponder, Ms. Council, and Mr. Franklin volunteered to serve on the Nominations Committee.

A slate will be prepared when nominations are sent into the Board Office. Nominations will be closed at the end of the May 18, 2017 full Board meeting.

### SEARCH COMMITTEE: Mr. Cantillo

The Committee met on March 27 and March 31. Interviews were held with three candidates. The Board will be voting in an Executive Session on the selection of Matthew Cruz as District Manager.

### HOUSING/ZONING COMMITTEE: Mr. Chirico for Mr. Sullivan

The Committee met on February 23, 2017 in which discussions were held on the development of property at Schley and Clarence Avenues and the reconstruction of the docks and runways at SUNY Maritime.

The Committee also met on March 13, 2017 in which discussions were held with St. Peter's Episcopal Church on possible development land and an unenclosed sidewalk café for Pizzaniste Restaurant. This item resulted in a resolution but could not be voted on at the March 16<sup>th</sup> full Board meeting because there was no quorum. It was a time sensitive issue and was voted on by the Executive Board on April 3, 2017.

The Committee met again on April 11<sup>th</sup> and discussed the following items: a kickboxing establishment at 3261 Westchester Avenue, 10461 and an unenclosed sidewalk café for Travesia Restaurant which resulted in a resolution:

**"Resolved**...at the recommendation of the Housing and Zoning Committee of Bronx Community Board #10 that the request for an unenclosed sidewalk café for Travesia Restaurant, 3830 East Tremont Avenue, 10465, DCA Application # 3408-2017-ASWC for 24 tables and 48 chairs be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Cantillo, seconded by Mr. Accomando and unanimously approved by all members. **The Resolution passed**.

### YOUTH SERVICES/EDUCATION COMMITTEE: Mr. Bieder
