

1st Vice Chair John Marano began the meeting at 7:15 p.m. with the Pledge of Allegiance.

Community Liaisons were introduced and thanked for coming.

PUBLIC PARTICIPATION SECTION:

1 – Marjorie Velazquez, CB #10 member: Ms. Velazquez notified the community about a fundraising event for St. Joseph's School for the Deaf, 819 Hutchinson River Parkway on 10/14/17 at the Con Edison Learning Center in Long Island City.

- Mr. Marano added that St. Joesph's is conducting a course on sign language, starting Monday October 3, 7:00 p.m., contact school for information.
- 2 Bobby Jaen, President, Throggs Neck Merchants Association: Mr. Jaen asked the community to give Made In Puerto Rico a positive vote in its request for a new liquor license; he also encourages participation in the fundraiser for St. Joseph's. On 10/26 there will be a Merchants Dinner at Villa Barone Manor; Throggs Neck BID has been certified; 2800 Bruckner Boulevard owners attended the Merchants meeting.
- 3 Beth Perricone, PS MS 194 in D11: The school staff is asking for community assistance with parking at the school; the perimeter is inundated with trucks, trailers, taxis taking up allocated space for the school; commended M. Cruz for his efforts; NYPD tow operation over the weekend but on Monday new tractor trailors etc. were parked; questioned the non-ticketing of abandoned vehicles while school employees vehicles are ticketed.
 - Mr. Bieder suggested looking the vacant property sites with parking on Waterbury Avenue which might alleviate the parking situation.
 - Mr. Marano advised Ms. Perricone to come to the October 11th Municipal Services meeting.
- 4 Jose Garcia, retired FDNY; Vietnam vet; talked about the low numbers on primary day and went over the voting numbers; disappointed in turnout.
- 5 Dior Doward, Greenfeen: talked about re-localizing waste; green jobs and green training (flyer).
 - Mr. Lynch will contact Ms. Doward about attending the October Parks committee meeting.
- 6 Lou Rocco, WSCA: Mr. Rocco wants to see more community effort in the Westchester Square area; he has concerns about unkept tree pits near the school. Mr. Rocco is unhappy with the Merchants associations and BIDs and some members of the Board.
- 7 Ashley Meza, Senator Bailey's Office: Contact Senator Bailey's office for additional information on an upcoming Disabilility Expo and a Human Trafficking workshop.
- 8 Lilyanna Pekic, Assemblyman Gjonaj's Office informed the community about the Donation Relief Effort for Puerto Rico, Mexico and Caribbean Islands being coordinated through the offices of Con. Crowley, Sen. Klein, Assem. Benedetto and Assem. Gjonaj. 718-409-0109
- 9 E. Sementilli, President, PBCISO: thanked the community for supporting him in the election. Mr. Sementilli is disturbed that the Ad-Hoc Over-Development Committee meeting of August 22 was closed and non-transparent; he accused the Board of trying to reign in the community; he wants the Board Office to notify the community of any Ad Hoc Over-Development Committee meeting and doesn't want this group to meet with any elected officials.
 - Mr. Marano advised any meeting in which the committee meets out of the office with an elected official is at the invitation of the elected official. The Ad Hoc Over-Development Committee is a mix of Board members and community members and all meetings scheduled by Community Board #10 are open and not secretive.

- 10 L. Brown NYPL, Baychester Library: discussed programs including family literacy to encourage the children to read. NYPL is sponsoring HOTSPOTS wireless devices for families with school age children. These devices will also be available at the Throgs Neck Branch. Contact each NYPL Branch for dates. A SNAP representative will be at the Throgs Neck Branch on 10/6/2017 from 10 a.m-6 p.m.
- 11 Edwin Rivera, Homeward Bound Program servicing disabled children, Zerega Avenue: wants a letter of support from the Board.
- 12 Jake Kuhl, resident of Edgewater Park: he is interested in partnering with local schools to implement financial literacy workshops through the Cents Ability non-profit program. Contact information: 646-404-4951, jake.kuhl@baruchmail.cuny.edu
- 13 Marie Dineen, resident of Arnow Place: daughter attends Preston High School; she wants street markings to delineate crossing for safety issues.
- M. Fernandez, A. Carbone, 2800 Bruckner Blvd.: Both Messrs. Fernandes and Carbone addressed the community and admitted the lack of communication and wants to assure the community that is not a homeless shelter/detoxification center, or chemical dependency rehab facility. It will be a sensory gym for children with early stage autism; educational/vocational training for veterans suffering from PTSD; peer advocacy, and a wellness center. Owners and management available on site for any questions. Community concerns have been heard and both look forward to being part of the community. mf@stewardrecovery.com

District Manager Cruz asked about the mattresses remaining in the building. Mr. Carbone said they will be moved to a facility which has housing. It was added that an advisory board will be created with community participation. The owners and facility management will be invited to a future Health and Human Services Committee meeting.

Board members would like more details about the programs to be offered, time lines for implementation, etc. Concerns about the lack of transparency were raised. Mr. Carbone added that there will be an M.D. overseeing the day to day operations. Mr. Salimbene asked about the veterans services, such as funding sources.

15 – J. Cerini, Pelham Bay resident: Mr. Cerini would like to see the Board become more involved in agency coordination for the reconstruction of seawalls; he also addressed the lack of transparency with information coming from the owners/management of 2800 Bruckner Boulevard. He added that notification concerning the sale and future use of the Whitestone Multiplex site should be obtained and made available; traffic studies for the arteries (Bruckner Boulevard lower and upper) including highways should be scheduled. He also added that the size of the printed announcements in the Bronx Times Reporter for public hearing notifications are insufficient.

Mr. Misiurski advised Mr. Cerini that seawall reconstruction is an item that is always put into the Board's Capital and Expense Budget Requests and has been for years.

16 – D. Poggi, Ferry Point Advocates: Ms. Poggi addressed the information that was posted on Facebook concerning a muslim wellness center at 2800 Bruckner Boulevard; she claims the

- community panicked; expressed concern over the elimination of community input by Throggs Neck Strong on Facebook; still uncertain and does not trust owners and management of 2800 Bruckner Boulevard. Ms. Poggi thanked Mr. Cruz for his efforts on this matter.
- NYS Assemblyman Mark Gjonaj: Assemblyman Gjonaj welcomed everyone back from the summer recess. He talked about the relief effort being coordinated by his office, Assemblyman Benedetto, Senator Klein and Congressman Crowley. He mentioned the Hutchinson River Parkway DOT study for a ramp from the Hutchinson River Parkway. Another topic he discussed was 2800 Bruckner Boulevard and added that there is a lack of information and lack of transparency; all the electeds will be vigilant in keeping an eye on this building. If it is discovered that the stated purpose of the building is other than what has been discussed, the money flow will be choked.

A motion to close the Public Participation Session was made by Mr. Cantillo, seconded by Bishop Rosario, and unanimously approved by all.

A motion to accept the minutes from the June 15, 2017 Bronx Community Board #10 meeting and the Public Hearing of July 25, 2017 were made by Mr. Salimbene, seconded by Mr. Russo, and unanimously approved by all.

BOROUGH PRESIDENT'S REPORT: B. Kemraj

Ms. Kemraj introduced herself to the Board and Community. She is now the Bronx Borough President's representative for Community Board #10; Mr. Lucania is her supervisor and Andy Toledo is her co-worker. Ms. Kemraj noted the relief efforts undertaken by the elected officials for the countries that suffered from the hurricanes. New Board member orientation is Monday at Lehman College.

Mr. Cerini asked about Borough President's position on 2800 Bruckner Boulevard and Mr. Russo asked about the Borough President's position on the Christopher Columbus statues. Ms. Kemraj would make inquiries.

DISTRICT MANAGER REPORT: Mr. Cruz

Mr. Cruz noted that 2800 Bruckner Boulevard was at the forefront this Summer and feels that everything will even out. He has attended many civic association meetings and borough consultations with many New York City agencies as well as Borough Board/Service meetings.

COMMITTEE REPORTS

EXECUTIVE COMMITTEE: Mr. Marano for Mr. Sullivan

The Committee met on July 5, and September 6, 2017. Minutes from both meetings are self-explanatory.

An evaluation form for the position of District Manager resulted in the following resolution:

"**Resolved**....at the request of the Executive Committee of Bronx Community Board #10 that the district manager evaluation form be forwarded to the full Board for approval."

The frequency of the evaluation will be either every six months or yearly, the full Board will do the evaluation and it will be signed by the Chairperson of Bronx Community Board #10.

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Cantillo and voted on favorably by a majority of members, with one vote against. **The Resolution passed.**

A second resolution was discussed:

"Resolved...at the request of Bronx Community Board 10, that the Projected FY 2018 Internal Budget including increased work hours for two staff members be adopted and presented to the full Board for approval at the September 28, 2017 Board Meeting."

A motion to accept the Resolution was made by Mr. Bieder, seconded by Mr. Boiko and voted on unanimously by all Board members. **The Resolution passed**.

HOUSING/ZONING COMMITTEE: Mr. Popovic

The Committee met on September 12. Meeting minutes are self-explanatory. The Ad-Hoc Development Committee met on August 2, 2017 and August 22, 2017 and minutes are self-explanatory.

The Co-op City Baptist Church at 2208 Boller Avenue came before the Housing and Zoning Committee but due to a lack of quorum at this meeting, a resolution will be presented to the full Board as a floor resolution on September 28, 2017:

"Resolved....at the request of Bronx Community Board #10 that BSA Application #2017-244-BZ, Co-op City Baptist Church, 2208 Boller Avenue, Bronx 10475, be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Boiko, seconded by Mr. Accomando and voted on unanimously by all Board members. **The Resolution passed**.

A Floor Resolution for Housing and Zoning and Economic Development concerning new liquor Licenses and Sidewalk Cafes was presented to the full Board for approval:

"Resolved....at the recommendation of Bronx Community Board #10 that the Community Notification Petition for a new food and drinking establishment seeking Board approval for a New York State Liquor License **OR** an establishment seeking Board approval for a New York City Department of Consumer Affairs licensed sidewalk café be forwarded to the full Board for approval."

A motion to accept the Resolution was made by Mr. Bieder and seconded by Mr. Accomando and voted on as follows: (22) twenty-two in favor, (2) two against, and (2) two abstentions. **The Resolution passed.**

ECONOMIC DEVELOPMENT COMMITTEE: Mr. Accomando

The Committee met on September 5, 2017.

Three establishment owners appeared before the Board on September 28, 2017 to provide additional information and answer questions about their respective establishments.

Mr. Gregory Pinnock, Manager of the Garage on Tillotson Avenue came before the Board to address community concerns; there are 32 cameras inside/outside establishment, security on staff, id scanner is used; Sgt. Dean of the 45th Precinct is on site at closing, hires local residents, installed additional exterior lighting. Board members suggested raising the age from 21 to 23 and instituting a dress code once a week.

Mr. Fabricio Alonzo, Owner of Made in Puerto Rico on East Tremont Avenue, accompanied by Ms. Aurelia Taveres, Business Consultant representing several bars on East Tremont Avenue: Mr. Alonzo was the previous bar manager of the establishment and was unaware of the problems plaguing the surrounding blocks. He has hired security who will patrol the surrounding area at closing as well as cleanup of the area, change closing hours to 3 a.m., and works with Sgt. Dean of the 45th Precinct.

Mr. William Padilla, Mr. Jeff Levine, Mr. Carlos Revelo, partners in Mamajuana on East Tremont Avenue discussed traffic issues and said that these have been corrected, parking is at the rear. All are working with Sgt. Dean about incidents that have occurred outside the establishment. Mr. Accomando brought up an issue with underage drinking as the establishment was cited on multiple occasions. Concerns were raised over the incident inside the establishment which was not originally reported. Board members want more cooperation from the establishment.

The following resolutions were voted on by the full Board:

PARKS/RECREATION COMMITTEE: Mr. Lynch

The Committee met on September 18, 2017.

Over the summer many summonses were issued in Ferry Point Park on a variety of infractions. Renovations in Colucci Park were completed this summer. NYC Parks is cleaning up the Bruckner skate park at MS 101/PS 304 along the Cross Bronx Service Road. Another Take Bake Our Parks event is being held in Bufano Park this coming weekend. On October 3, a ribbon cutting ceremony in Pelham Bay Park is being held to showcase the new adult exercise equipment.

PLANNING/BUDGET COMMITTEE: Mr. Misiurski

The Committee met on September 25, 2017. Minutes are self-explanatory. The Board's internal budget was reviewed. There is a surplus of monies, some of which will go towards extra hours for two staff members and resulted in a Resolution which will be presented to the full Board on September 28, 2017. On October 4, 2017 a Public Hearing on the Capital and Expense Budget Requests will be conducted and will be followed by a Committee meeting. 9/25/17
