





## EXECUTIVE BOARD MEETING JANUARY 4, 2016

Mr. Prince opened the meeting with the Pledge of Allegiance and a discussion regarding the Economic Development Committee. His comments centered on the Stipulations and how the Board was signing off on them, before the establishment came before the Committee. He further commented on the overall importance of the stipulations, because during the recent MARCH Initiative, they were used to assess an establishment's performance by the NYPD. Mr. Prince commented that there would be an administrative change in the manner in which the stipulations were signed they will only be signed by the Chairman, after the establishment's representatives have met with the Economic Development Committee. The applicant will sign the stipulations at the meeting. The Committee's decision, if favorable, regarding the application will be forwarded to the full Board in the form of a support Resolution. A letter will be generated after the full Board vote to the State Liquor Authority indicating the Board's approval. In the event that the Committee turns down an applicant, an appropriate Resolution will be drafted and reported to the full Board, where it be voted on, and a letter will sent to the State Liquor Authority recording the Board's negative vote.

There ensued a discussion where concerns were raised that the process described in the above paragraph may slow things down, creating delays for bar owners. This was answered by pointing out that the Economic Development Committee meets frequently enough, so that the procedures described above paragraph, should not be a factor that causes difficulties for establishment owners. Other issues discussed were the influence of social media and a fear that posts by community residents may unfairly influence the Committee members. It was suggested that we have new owners of establishments at the Committee meeting, as well as those owners seeking renewals of their licenses (this is done). It was further suggested that that the Committee have access to Police reports (this is done, when they are available), that all owners of establishments be invited to the full Board meeting. Other concerns raised were that all owners of establishments be provided with copies of the new stipulations, that the Board could modify any stipulation suggesting a "last call" at about 3:00 AM and all complaints regarding establishments must be registered with 311.

The discussion shifted to the importance of the Board in having a strong system of Co-Chairs in place for all of the Committee Chairs. Most Committees already have Co-Chairs, but that system must be reviewed and tightened up, so that that there is a formally designated Co-Chair for every Committee Chair.

There was further discussion concerning the Veterans Affairs Committee and its purpose and governance. It was determined that there would be a Veterans' Affairs Sub-Committee that would report to the Health and Human Services Committee. This sub-committee would be co-chaired by Mr. Devine and Mr. Salimbene. Dr. Hunt thought that the sub-committee's purview should cover all veterans' issues, not just

health. There was some conversation to the effect that after a period of time, the sub-committee could become its own committee. Mr. Salimbene suggested that the Board contact the Borough President to obtain copies of his booklet concerning veterans' rights. There was also a suggestion concerning partnering with organizations like Montefiore on provision of services for veterans.

There was a short discussion concerning the accumulation of annual leave by the District Manager and a management plan that would limit the accrual of such time by the District Manager, by not having him attend as many committee meetings, as he had in the past. Also discussed was the possible use of the Board's Secretary to take notes for the Executive Board. This suggestion was discussed with Mr. Barbarelli, the Board's Secretary and he was asked to consider it. Mr. Sullivan requested that the District Manager continue to take notes for the Housing and Zoning Committee.

The discussion shifted to the establishment of a Sargent of Arms position to keep the general Board meeting moving, reminding people that they are coming close to or exceeding the three minute period allotted to speakers, that all of the Board members sign in, that all of the Board members, especially those coming in late have that lateness recorded and similarly have those who leave early noted in the attendance records. It was felt that five members were needed as Sargent of Arms to do this work. Messrs. Barbarelli and Marano volunteered to serve as Sargent at Arms. They were acknowledged and thanked for the voluntary efforts.

The topic of attendance at the both the Committee and General Board meetings was discussed. A question was posed as to whether the Board needs an ad hoc Committee to review attendance, as the Board had in the past. It was determined that Board once again use the Committee system and it should be set up in in later September or early December. As in the past the Committee would rely on the existing By-Laws in reviewing attendance issues. However, if the excessive absence is due to medical reasons, that situation would always be factored into any analysis.


Mr. Russo briefly discussed the State's plan for the I95 corridor, which included statements that the New York State Department of Transportation will eventually present the plan for review by stakeholders, including the Community Board and that we are free to look at the existing plan to discuss it and make recommendations. The issue of Bronx Community Board #10 seeking Co-Terminality status with respect tom the development of the mall at Gun Hill Road was discussed, and how the Board requested this status of City Planning. A meeting with Montefiore to discuss conditions at the Weiler Hospital was also discussed.

It was brought up that Senator Klein wanted to use the office space for a meeting with the New York City Department of Education to discuss the problems associated with the Lehman High School campus. The Board provided the space for a meeting on January 8<sup>th</sup>.


Under new business, Mr. Sementilli, a guest, brought up the Pelham Grand site at 1870 Pelham Parkway South, and how in his opinion, the Board was lied to by the sponsor ASC/NYC, during a meeting of the Municipal Services Committee, where several possible occupants for the site were invited to the Board to talk about their programs. It is his contention that that ASC/NYC had a contract in place, at the time of that meeting with the landlord and that their representatives should have told the Board that. He would like to Board to pursue an investigation on this matter and to take ASC/NYC to task on this issue.

He further objected to the Board's use of e-mails to discuss policy matters, requesting that all business of the Board be conducted at the Board's public meetings.

The meeting concluded at 9:00 PM.

On December 4-5, there was a March Event initiated by the 45<sup>th</sup> Pct. A March Event is a collaborative effort where several City agencies—NYPD, FDNY, Consumer Affairs, Buildings Dept, Health Dept—inspect an establishment, based on complaints to 311 and the 45<sup>th</sup> pct. The results of the investigation, including the establishments involved and the types of violations, were announced and discussed.

Some restaurant owners felt that the March event was too harsh a method, especially in this economy, whereas others felt that owners should take responsibility and cooperate with the surrounding community.

A future meeting will include a discussion on proposed new Stipulations, as soon as all community and business responses have been correlated.

The meeting was adjourned at 9:20 PM.

Commissioner Moran along with Novardo Lopez and Naim Rashid of DOT presented a preliminary study to add an exit off the Hutchinson River Parkway into the Hutch Metro Center including 16 to 20 intersections within community boards 10 and 11. The study should be completed by July and DOT will return with their findings in September or October 2016. They are looking at the effects of the Metro North Station and working with the Empire State Development Corp with respect to the expansion at the Bronx Psychiatric Center.

Jorge Santiago brought up the fact that the signs at the Shore Road Circle do not include the Bartow Pell Mansion. The commissioner will look into correcting the situation. Michele Torrioni brought up missing stop signs at Mayflower and Middletown Roads. The commissioner will correct this.

Dear Mr. Kearns,

My name is Toni Agovino and I am the daughter of Al Agovino Sr. I am requesting that Harrington Avenue between Mayflower and Edison be named after my Dad. This is my official letter requesting a street overlay.

My Dad spent most of his life helping others. He was a member of one of the original Knights of Columbus (St. Luke #438 in Pelham Bay) for years and was also Grand Knight for three years. He spent years as the head usher of St. Benedict's and one of the only lay men to ever hold the keys to the Church. He was a longtime member of the Holy Name Society and one time President. He held one of the most successful blood banks ever at St. Benedict's by collecting over 100 pints of blood in one day.

He was particularly involved with helping the developmentally disabled the last four decades if not longer. He was a lifetime member of the AHRC New York City Chapter, their President for three years and served on their Board of Directors for over three decades. He served on the Bronx Consumer Council, Bronx Developmental Disabilities Service Office Parent Association, and New York State Commission on Quality Care for the Mentally Disabled Advisory Council and numerous other organizations where he devoted his life to helping others.

I can write volumes on this incredible man and all that he has done for others. He received countless awards and a Congressional Record in 2002. He also had a special proclamation given to him by Governor Pataki in 2002 as well. Helping others is what made my Dad happy. He wanted to advocate for those that were unable to advocate for themselves and make sure that they had an excellent quality of life.

My Dad answered calls at all hours of the day and night so he could be available to help parents of developmentally disabled children and adults. If he did not have the answer to a question or problem, he did not stop until he was able to provide helpful information and help resolve the issue. He also followed up to make sure that you were getting the help or information you needed – that is just how devoted he was to helping others.

My Dad was also a World War 2 veteran. He received the American Theater Medal, Asiatic Pacific Theatre Medal (3 stars), Philippine Liberation Medal (2 stars) and the Victory Medal.

My Dad was a great, great man who gave so much of himself to helping others. It is an honor and a privilege to be his daughter. I would like my Dad's legacy to live on and I would love to have Harrington Avenue between Mayflower and Edison named after him. I was hoping that you can help me and guide me on the direction of what needs to be done.

I hope that you will consider this request and give it your fullest attention.
