

### **BOROUGH PRESIDENT'S REPORT:** Ms. Kemraj

Ms. Kemraj advised the community that applications for board membership are available; high school students are encouraged to apply, ages 16 and older. Deadline is February 9, 2018.

#### **DISTRICT MANAGER REPORT**: Mr. Cruz

There was a recent fire at the Throggs Neck Houses where a father and daughter died due to a hot plate setting fire to bedding. Mr. Cruz will be attending the Throggs Neck Resident Council meeting at which there will be discussion on heat, hot water, lead and other issues.

Mr. Cruz has a weekly column in the Bronx Penny Pincher and encourages all to read and catch up on events. He also noted the monthly activities in each NYPL on technology, childrens' programs, etc.

New signage was installed on I695 towards the Randall Avenue exit. 3250 Westchester Avenue, 10461 zoning was approved by the Department of Buildings for a tall structure (10 Stories). The building plans have not yet been approved. The Board will monitor this location closely and keep the

community informed. The food cart vendor license, located on East Tremont Avenue at CVS, has been suspended by the DOH. Mr. Cruz has be in contact with the 45<sup>th</sup> Precinct concerning the tractor trailers parking throughout the community. Mr. Cruz will follow-up with the NYC Department of Transportation concerning a traffic light at the intersection of Revere and Miles Avenues. A public hearing concerning 3660 East Tremont Avenue (McDonald's) is to be scheduled.

### **COMMITTEE REPORTS**

#### **EXECUTIVE COMMITTEE:** Mr. Sullivan

The Committee met on January 16, 2018. Minutes are self-explanatory. Discussion on By-law changes took place which will be forwarded to the Board members prior to the February Executive Board meeting.

Mr. Sullivan noted that the By-law change for the nomination/election portion concerning attendance on a second standing committee pertains only to any Veterans Services Committee member if he or she plans on running for an executive officer position.

### **PLANNING/BUDGET COMMITTEE:** Mr. Misiurski

The Committee met on January 8, 2018. Minutes are self-explanatory. The committee discussed the 2018/2019 budget. Mr. Misiurski thanked his committee members for 100% attendance.

### **HOUSING/ZONING COMMITTEE:** Mr. Popovic

# **Request for Letter**

"Resolved... at the recommendation of the Economic Development Committee of Bronx Community Board #10 that a letter be written and sent to Tosca Marquee regarding discrepancies on the types of liquor licenses the establishment possesses and this issue be resolved within 10 business days upon receipt of this letter and that this request be forwarded to the full Board for approval."

A discussion among Board members began, with one questioning why this was being done. It was stated that there is some discrepancy in the type of license for the Tosca Café and Marquee and the recommendation for the letter came from the Economic Development Committee. A motion to prepare and write a warning letter was made by Ms. Chambers and Mr. Boiko. A second motion to table the resolution was made because it was noted that some information is being provided which may answer the license discrepancy issue; this motion was made by Bishop Rosario, seconded by Mr. Marano and was approved by a majority of members with one opposed and one abstention (Mr. Bieder, Mr. Onwu, respectively).

# **VETERANS SERVICES:** Mr. Salimbene

Mr. Salimbene mentioned an anti-bullying effort funding through the City of New York by way of the National Guard, which is on hold due to the upcoming departure of the Department of Education Commissioner. Monitoring of the golf carts used at the Veterans Administration Hospital to assist in the transport of disabled vets around the grounds will be done periodically; veterans will now have permanent representation at the MTA's hearings on reduced fare by Mr. Peter Del Debbio. Next Committee meeting will be on February 23, 2018 at the Samuel Young Post.

#### **OLD BUSINESS:**

A discussion among Board members began about the conditions at Montefiore/Einstein Weiler Hospital. A request was made for CB #10 to reach out to surrounding Boards to try to work on an approach to raise awareness and improve conditions. Dr. Hunt and Bishop Rosario asked Board members and the community to provide in writing details about experiences at Weiler, such as doctor and nurse names, dates, documentation from hospital. Specifics are very important, not just comments on unsatisfactory care. Mr. Cruz will reach out to CB #11 to see if there is a way to work jointly. It was stated that Assemblyman Benedetto should be able to obtain reports on hospital operations relating to Montefiore.

#### **NEW BUSINESS:**

Coffee with a Cop, building relationships – January 24, 2018, 6 p.m.-8 p.m. at the Miles Coffee Bar on East Tremont Avenue.

Dr. Ponder commended Ms. Monique Johnson in her role as Tenant Association President of the Throggs Neck Houses and her dedication to the residents.

Mr. Jose Rodriguez of Senator Klein's Office, informed the community that Senator Klein is committed to having the apartments in the Throggs Neck Houses tested. As of this date, thirty-seven children will be tested for lead poisoning. More apartment testing will be done.

Mr. Boiko informed the community about a meeting at Riverbay on January 23<sup>rd</sup> concerning the 300' structure at the Baychester/Bartow Avenues strip mall.

On February 1, 2018 at 7:30 p.m. the NYPD Police Commissioner will be at the 45<sup>th</sup> Precinct Community Council meeting, location is St. Theresa's Parish, 2855 St. Theresa Avenue, 7:30 p.m.

Motion to close the January 18, 2018 Community Board #10 meeting was made by Mr. Bieder, seconded by Mr. Accomando and unanimously approved by all.
