## October 5, 2016 Parks & Recreation Committee Meeting Minutes

Meeting called to order at 7:05 p.m.

- 1. Brief presentation by NYC Parks Department concerning updated information on the Van Nest Flag Pole. Some adjustments were made to the original plans that were suggested at the Van Nest Neighborhood Alliance meeting in February. Mr. Schneiderman and Mr. Frindt both gave information on the preservation of historical materials being removed or replaced at the site. Additional funding will come from DEP for storm weather management. Construction is scheduled to begin sometime in 2017.
- 2. Committee members reviewed items to be placed on the Budget Priorities for FY 2017. There was discussion about Eastchester Gardens Playground. KEITH RAMSEY SUBMITTED A REQUEST FOR ADDITIONAL FUNDING TO COMPLETE WORK ON THE PLAYGROUND, AND ADD SOME ADDITIONAL EQUIPMENT. COMMITTEE AGREED THAT DISTRICT MANAGER, JEREMY WARNEKE SHOULD REACH OUT TO IRIS RODRIGUEZ, NYC PARKS BRONX COMMISSIONER TO FIND OUT WHAT HAPPENED TO THE MONIES THAT WERE APPROVED FOR A FULL RENOVATION BY THE COMMITTEE AND THE FULL BOARD. MOTION WAS MADE BY THE CHAIR AND APPROVED BY COMMITTEE MEMBERS THAT KEITH SHOULD SPEAK WITH COUNCIL MEMBER ANDY KING TO REQUEST ADDITIONAL FUNDING, BECAUSE EASTCHESTER GARDENS IS IN THE COUNCIL MEMBER'S DISTRICT.
