Motion by Joseph McManus, Seconded by Al D'Angelo – To send the following statement to City Planning: We the Members of Bronx Community Board 11 write to express our concerns with the Mayor's proposed Zoning for Quality and Affordability and Mandatory Inclusionary Housing plans. It is understood that there is a housing crisis in the City, but before a citywide zoning text amendment is approved and instituted, we the Board would like to iterate that a one-size-fits-all model will do more harm than good. We understand that the City Council is currently negotiating changes to the plan. We have been in communication with our local Council Member, James Vacca, who is advocating for more consideration to be taken for the mass transit plan. We support his advocacy efforts to preserving parking requirements and height requirements. We also support him to speak on all of our objections submitted to City Planning. As a Board, we appreciate that a plan is needed to help the City out of the housing crisis. However, we hope that you are able to negotiate with our Council Member and the entire City Council on a plan that is friendlier and more applicable to neighborhoods like ours.
