Mr. Prezioso called the meeting to order at 7:01 p.m.

1. Street Activity Permit Applications. Kristin Faiella appeared on behalf of Daniella Nicoletti in support of Tenbroeck Block Party, Yovanna Perez appeared in support of Coops Family Day Block Party.

Motion by Joseph Thurston, seconded by Joseph Bacote – that CB 11 recommend approval of Tenbroeck Block Party, Coops Family Day Block Party and Fellowship Tabernacle Ministries Religious Ceremony. **UNANIMOUSLY PASSED.**

Corina Pintor appeared on behalf of Fun Day 4 Block Party sponsored by Bronx House and proposed to close Pelham Pkwy So. between Hone and Bogart Aves. Mr. Prezioso explained to Ms. Pintor that the Pelham Pkwy. service road is a main thoroughfare that cannot be closed. Ms. Pintor said she would take this up with the City. Motion by Vinny Prezioso, seconded by Frano Zagreda – that CB 11 deny approval of Fun Day 4 Block Party. **UNANIMOUSLY PASSED.**

2. Request Dept. of Transportation to conduct a study to determine if Seminole St. can be converted to one-way in either direction. (Tabled at last full Board meeting).

As a decision by requestors as to preferred direction of one-way was not received, this item was not discussed at today's Transportation Committee meeting.

3. Old Business.
 - a. White Plains Road congestion. Chris Kirka advised that DOT has notified CB 11 office that Bronx DOT Commissioner Connie Moran will do walkthrough with Van Nest Association of this area.
 - b. Speeding on Gunther Ave between Mace & Waring Avenues. Joe Bacote asked that CB 11 follow up with Connie Moran about installing 25mph signs in this area. Mr. Prezioso requests that District Manager send letter to Ms. Moran with this request.
4. New Business.
 - a. Request for CB 11 support for event on Britton between Barker & Olinville Aves. Esamar Medal stated that the event she is planning was held last year under auspices of Dept of Parks which had many limitations. She would like to do a street closing instead. Mr. Prezioso suggested she return with petition signed by people on street to be closed by June 20th. She should also secure her FDNY permit for generator and sound permit from NYPD. Motion by Vinny Prezioso, seconded by Joseph Thurston – that if Ms. Medal provides petition and permits by June 20th, Committee will recommend that CB 11 recommend approval of this event.
