Public Hearing on the Register of Community Board Requests for the Preliminary Budget Fiscal Year 2010

The meeting of the Public Hearing on the Register of Community Board Requests for the Preliminary Budget Fiscal Year 2010 was held at The Bronx Lebanon Hospital, Murray Cohen Auditorium, 1650 Grand Concourse, Bronx, NY. The Hearing was called to order by the Board Chair, Ms. D. Lee Ezell at 6:25pm.

Ms. Ezell, Board Chair gave welcoming remarks and began by giving an overview of the budget process, the Community Board's role and its responsibility involving this Charter mandate. She informed all in attendance that this portion of the meeting will be Community Board Four's Public Hearing on the Preliminary Budget for Fiscal Year 2010.

Ms. Ezell, Board Chair began by outlining the hearings procedures and then announced the guidelines for speaking and then proceeded to call individuals who signed up.

Jesus Aguina, spoke of supportive services for substance abuse. Martha Esperanza of Sharing and Caring spoke of the services of health care services.

Board Member Mr. Ryan Khan asked for Expense item priority 16 to be moved to priority 6 and all other items to be in succeeding order. The motion was presented by Mr. Khan and seconded by Mr. Carlos Sierra. Motion was duly carried.

Board Member Mr. Robert Garmendiz asked for capital listing priority number 34 be rephrased to read that the Parks budget should equal 1% of the of the City's total budget. The motion made by Mr. Garmendiz was seconded by Barry Nissen. The Motion was duly carried.

The Board Chair acknowledged Ms. Holly Block, Executive Director of the Bronx Museum of the Arts. Ms. Block spoke of the budget cuts that the museum will be facing this fiscal year. The proposed cuts will affect their garden initiative and in addition, the \$1.5 Million cut will cause the museum to reduce their gallery production. The 60% cut from DCA will also affect youth activities and the partnerships that the Museum has established with our neighborhood schools. Ms Ezell thanked Ms Block and the Museum for all that they do on our behalf. She then asked Ms. Block to briefly outline what support Board Four may specifically provided. The Museum requested a letter of support for their garden project. Ms. Ezell proceeded to ask Pastor Jackson, has the Parks Committee Chair if he had any comments on the garden project. Pastor Jackson's inquiry was regarding the proceeds from rentals and if they directly benefited the Museum.

A motion was called by Ms. Martha Reyes and seconded by Mr. Barry Nissen to grant a letter of support to the Museum. The motion was duly carried.

Mr. Manuel Martinez made mention of the priority order of Capital request item, the Highbridge Dough Boy Monument. The District Manager acknowledged Mr. Martinez's request and indicated that he will seek to obtain clarification from OMB. A motion was made by Pastor Wenzell Jackson and seconded by Ms. Rosie Pettway to ensure that OMB indeed correctly prioritized our request of the Highbridge Dough Boy Monument. The motion was duly carried. Ms. Rosie Pettway proceeded to make a motion relating to our Capital and Expense request however, the District Manager suggested that a motion may not be necessary but the decision was up to the Board on the best course of action. The full Board requested that the District Manager review the adopted budget priorities in October and compare them to the preliminary budget document provided by OMB.

A request was made by the community to receive a copy of the budget documents and It was suggested that the Board office send an email directing community members and organizations on were to retrieve the budget documents that the Board was referring to during the Public Hearing.

At this point the Board Chair concluded the Public Hearing on the Register of Community Board Requests for the Preliminary Budget Fiscal Year 2010.

Call To Order of the General Board Monthly Meeting

D. Lee Ezell, Board Chair welcomed all in attendance to the meeting. She also called for all members to participate in project envision against sexual assault which will be held instead of the Executive session on 5 March 2009.

Review/Correction/Adoption of Previous Minutes

The Board Chair D. Lee Ezell called for a review of the January General Board Meeting Minutes to be adopted. A motion was made by Robert Garmendiz and seconded by Felice Bradford-Richard. The motion was duly carried.

Vote on FY2010 Capital and Expense Budget Priorities.

At this point the Board Chair reviewed all matters discussed at the Public Hearing. Pastor Jackson requested clarification on the Vote which prompted the Board Chair to acquiesce and called for a motion to be made on the afore-mentioned items. The motion was made by Ms Kathleen Saunders and seconded by Dr. Nabinet. The motion was duly carried.

Appointment of Nomination Committee

Ms. D Lee Ezell, Board Chair announced that the Nominations Committee was unable to meet during the month and indicated that the Board would have to wait until our General Board Meeting in March. Ms. Ezell announced that there is a new appointment not subject to Board election rules but an appointment by the Board Chair. Manual Martinez was appointed by the Board Chair to the Bronx Solid Waste.

By-Laws Committee Report

A discussion commenced on the best mechanism to properly coordinate the development of the new by-laws. Pastor Jackson explained how certain areas of the by-laws will be address first, such as committees and committee membership. The revised items will be presented to the members for a vote. Pastor Jackson also indicated that the committee may email their completed recommendation. Ms. Ezell asked if the Board was in agreement with Pastor Jackson's suggestion.

Board Members again asked for clarity on how the Committee will coordinate their efforts. Ms Ezell referred to the motion that Pastor Jackson made. The motion made by Pastor Jackson and seconded by Mr. Barry Nissen to send copies of the results of the By-Laws Committee's work on the section relating to Committees and Committee Membership. The motion was duly carried.
