Budget Chair D. Gellman asked for speakers.

1. Robert Press commented and offered suggestions on both the capital and expense budget items for FY 2019. D. Gellman made note of his comments.

Not hearing from any additional speakers, Budget Chair Gellman called for a vote to close the hearing.

Chair Ginty convened the meeting at 7:30 P.M.

- 1. Gallery Session No speakers
- 2. Report from the 50<sup>th</sup> Police Precinct DI O'Toole
  - 28 day comp stat report 2017 vs. 2016, murders 1 vs.1, rape 0 vs. 1, robbery 8 vs. 12, felony assaults 12 vs. 11, burglary 10 vs. 10, grand larceny 53 vs. 41 and grand larceny auto 2 vs. 6. Total of 86 crimes vs. 82 crimes.

- There was a video shown of an arrest by an officer from the precinct. The police officer acted lawfully.
- Lighting in the Marble Hill area has improved but it could be better.
- Senior safety bags are being distributed at Senior Centers.

### Chair Ginty welcomed Assemblyman Dinowitz to address the board

- Met with leaders of 2 NYCHA facilities, Ft. Independence and Marble Hill. Received funding more than a year ago for lighting and is awaiting the installation of these lights in the near future.
- State Budget may be revisited in Albany.
- Reminder Turn ballot over on Election Day and suggested voting no for the constitutional convention.
- Supports the board's request for new office space in a central location of the district.

## Chair Ginty welcomed Senator Klein to address the board

- Wrote to the Mayor on behalf of Community Board 8's search for new office space.
- Secured funds to revive Mitchell-Lama housing/Mitchell-Lama 2020 to rehabilitate existing Mitchell
  Lama buildings and provide more affordable housing for middle income families with incomes up to
  130% of the AMI. He also proposed refundable tax credits to incentivize the creation of units of
  affordable housing.
- Senior Citizen Rent Increase Exemption (SCRIE) Program and the Disability Rent Increase Exemption (DRIE) Program helps those eligible stay in affordable housing by freezing their rent. These programs were raised to families with an income level of up to \$50,000.00.
- Senior Citizen Homeowners' Exemption (SCHE) program provides a property tax exemption for senior citizens who own one, two, or three family homes, condominiums, or cooperative apartments. All owners must be 65 years of age or older in the year that they apply. Raised eligibility to \$58,600.
- Doubled tax break for child care.
- Score cards will be displayed at the entrance of child care centers.
- Suggested the board send our budget priorities to him to see if he can be of assistance.

  - The Chair announced that the Department of Homelessness forum took place in late September. It

was a useful event. The Bronx coordinator of homeless services is expected to attend an upcoming housing committee meeting to talk about why and how the 380 individuals in CB8 are homeless/became homeless. The Chair and Vice Chair will meet with the Bronx coordinator of homeless services to discuss this further.

B. Land Use – Chairperson R. Ginty - Chair and Vice Chairs absent

Chair Ginty brought forward the following resolution on Wave Hill's capital project:

WHEREAS, representatives of Wave Hill presented their plans for a Capital Project, LPC-19-13260, 675 West 252 Street, Wave Hill House, to the Land Use Committee on September 5, 2017; and,

WHEREAS, there were concerns/questions expressed by two board members; and,

WHEREAS, Wave Hill representatives said they would respond to the concerns in writing;

Therefore, BE IT RESOLVED that the Land Use Committee approves the Capital Project for Wave Hill subject to Wave Hill responding to the concerns in writing before the Community Board vote.

It was also strongly felt that if these students attended local schools before entering a shelter they should be given the choice of returning to their school.
