Meeting called to order at 4:30PM by Chair E. Dinowitz at Atria Riverdale

1. Speaker C. Smith discussed fall prevention for older adults.

-History: there are approx. 300 fall related deaths annually in NYC with 50% falls occurring at home. 40% of those hospitalized go to long term care. Falls aren't considered a normal part of aging. In the period 2005-2012 falls increased across all economic levels with Staten Island having the greatest increase of fall frequency.

-Risk: age related changes, i.e. muscle weakness, gait pattern and balance, declining vision and hearing, medical conditions including Parkinson's and depression, environmental hazards indoors/outdoors, history of and fear of falling, behavioral i.e. footwear and alcohol usage, lighting.

-Resources: many provided free by the NYC (befitnyc.org and NYC Parks Dept.) or by calling 311 which can provide a home safety checklist.

-Reminders: if recommended, use cane/walker for all ambulatory activities. Have a phone within easy reach for 911 calls in event of a fall. Utilize grab bars in shower, tub, toilet area; use a shower bench, detachable shower head, nonskid bath mats since many falls happen in bathroom.

-Prevention: In addition to making home safe, exercise is the most important thing one can do to prevent falls.
