### Introductions

- Chair thanked our host Lourdes Santacruz, Methodist Home
- Participants introduced themselves. Mr. Christner thanked RSS for taking on Healthy Community Initiatives from Bon Secours - Schervier
- Adjusted order of agenda. This is our third senior center roundtable

**Topic – NYC Commission on Human Rights** – with speakers Kajori Chaudhuri & Beth Miller Ms. Chaudhuri explained that the Commission, under NYC Human Rights Law, serves to fight discrimination in housing, public accommodations and in the workplace. This includes discrimination on the basis of age, race, gender, religion, national origin, marital status, sexual orientation, disability, citizenship status and certain other bias-based profiles. The speakers answered questions and provided examples of what constitutes reasonable accommodations in housing and public places. People may not feel comfortable reporting harassment and discrimination to the police. The Commission investigates and prosecutes claims within their jurisdiction and also provides education and training. Contact 311 and ask for Human Rights

There is an increase in harassment towards people who are Jewish, Muslim, Sikh, Arab and South Asian. Ms. Miller is reaching out to organizations to gain participation in a survey. The survey gathers input from residents on how discrimination impacts communities. This will help NYC to direct resources. She encourages participation in this survey. nyc.gov/humanrights

# Topic - Our Senior Centers - with guest, Karol Tapias, LiveOn NY

Ms. Tapias introduced LiveOn NY, an organization that supports agencies serving older adults through advocacy, policy, funding issues, training, programming as well as direct assistance. She noted that citywide, senior centers are reporting an increase in program participation. One center noted this shift towards program v. meal participation. The city increased its budget for supporting older adults in the *Year of the Senior, in part* to recognize senior centers' higher administrative/salary costs and increased attendance. Fund disbursement is pending the city's model budgeting initiative to understand need and measurements for fair distribution. LiveOn will meet with senior centers to discuss. RSS is reaching out to bring in older adults from underserved areas. RSS and Y see an increase in participation of younger seniors and are adjusting programming to meet the age spectrum. RSS' social action committee is active. The center has a temporary reprieve from transportation changes. Ms. Butler shared an introduction to NORCs. Natural Occurring Retirement Communities put services in the community to help people age in place. Group discussed the need for doctor appointment escorts and limited assistance

#### **Minutes**

The New Jewish Home clarified that their medical model day program operates on their Bronx campus and that they no longer operate a social model day program. Committee approved the September 19, 2017 minutes as amended (6/0/0)
