- Speaker Bayla Butler of the Almalgamated Park Reservoir (AmPark) NORC (Naturally Occurring Retirement Community)
 - Almalgamated and other NORC's (54 in NY) are located in housing complexes that were not originally built for seniors. The NORC Senior Service office works with all residents who are aged 60 years and over to enable them to age safely in place. The NORC community itself is multi-generational.

NORC's are a three party partnership that at Amalgamated includes a housing entity (Amalgamated Park-Reservoir Houses), a non-profit (Bronx Jewish Community Council) and a health care entity (Jewish Home Life Care). The AmPark NORC is also funded in part under contract by the New York State Office for the Aging and the New York City Department for the Aging.

- Client base: over 500 of the approximately 4500 residents.
- Staff: Registered nurse, licensed social worker, and case manager
- Services are provided free of charge to all seniors and by extension to their families and caregivers.
- NORC Advisory Council: meets monthly with community members and community partners to identify needs and to plan programming. Mission is to build a strong sense of community of care in order to foster, support and maximize each person's overall wellbeing.
- Demand: Amalgamated is a low to middle income limited equity cooperative. There is currently a 3 year wait list.
