2. Speaker, Ellen Camerieri, White House Conference on Aging, 2006

The first official White House Conference on Aging was held in 1961, attended by Irving Ladimer. The last conference prior to the 2005 was held in 1995. Attendees were appointed by government officials, as was Camerieri, with some at-large-reps, including those well known for involvement in aging issues. The Policy Committee developed the agenda and resolutions and was unwilling to fluctuate from those. There was little opportunity for input, resulting in the NY State Delegation, including Camerieri, to issue a statement of "serious concerns about the structure, process and anticipated outcomes of the 2005 Conference". The NY contingent wanted to be on record as opposing some of the proposals. Other major complaints related to late dissemination of materials and lack of opportunity for input on wording and prioritizing of resolutions. Presentations weren't geared to the advanced expertise and sophistication of many in the audience. There was concern expressed by attendees that the U.S. is behind in technology serving Seniors. The program emphasis seemed to focus on baby boomers and their needs, rather than identifying the spectrum of older adults who need care and attention. Neither President Bush or Mrs. Bush attended the Conference. For further information: White House Conference on Aging, Google or Yahoo.
