WHEREAS, the North Riverdale Merchant and Business Association (NRMA) comprised the "Riverdale, Bronx NYC Streetscape Report" dated July 2017 ("Streetscape Report") which can be accessed on the internet at: http://www.riverdalebronx.nyc/docs/streetscapereport.pdf;

WHEREAS, the Streetscape Report is labeled as "A Comprehensive Set of Ideas for Revitalizing Riverdale Avenue and Mosholu Avenue";

WHEREAS, on July 27, 2017, NRMA forwarded the Streetscape Report to the NYC Department of Transportation with a letter in which "the Association now asks DOT to consider and act on the recommendations in this report as soon as possible."

WHEREAS, Section 1.4(c) of the Streetscape Report reads:

Sidewalk on Netherland Avenue Connecting W. 256th and W. 254th Streets Netherland Avenue passes through the two cooperative apartment complexes just to the west of Riverdale Avenue. At W. 255th Street, a row of dumpsters and fencing prevents north south access. Several residents have asked the Association to ask the City to explore the creation of a safe sidewalk path in cooperation with neighboring cooperatives.

WHEREAS, on October 17, 2017, NRMA presented its Streetscape Report at a public meeting of the Traffic and Transportation Committee of Bronx Community Board No. 8 ("Committee") asked that the Committee asked that the Committee call for a

WHEREAS. On November 30, 2017 the Committee discussed and voted on a resolution regarding the Streetscape Report;

WHEREAS, at the meeting on November 30, 2017, members of the public rejection of the Netherland Avenue sidewalk path;

WHEREAS, the Committee stated that the Netherland Avenue connection would be more fully discussed at a subsequent Committee meeting;

WHEREAS, Bronx Community Board No. 8 ("Board") discussed and passed the Committee's resolution on the Streetscape Report at its December 12, 2017 general meeting;

WHEREAS, the Netherland Avenue path was placed on the February 15, 2017 Committee agenda for discussion;

WHEREAS, approximately 250 residents appeared for the Netherland Avenue sidewalk path agenda item;

WHEREAS, the Committee heard approximately two hours of testimony on the Netherland Avenue path;

WHEREAS, a few members of the public stated that the creation of a path would be a convenience to the community;

WHEREAS, the overwhelming number of attendees at the meeting opposed the creation of a path and expressed concerns about security, cleanliness and impact on the neighboring developments;

WHEREAS, many attendees from the neighboring developments, including both tenant and owner representatives, stated that there was no outreach to their residents, associations, boards, management or ownership prior to the Streetscape Report's transmission to DOT;

WHEREAS, many attendees questioned the reasoning behind the inclusion of the Netherland Avenue sidewalk path in the Streetscape Report;

BE IT RESOLVED THAT, after due consideration of the issue, the Traffic and Transportation Committee opposes the opening of a sidewalk path on Netherland Avenue between West 254th Street and West 256th Street.

WHEREAS.

1. The Land Use Committee of Community Board 8 at its December, 2017 heard CPC Application N 180136ZAX and N180137 ZAX with respect to premises at 5297 Independence Avenue (Block 5939, Lot 410), a corner property, located in the

Special Natural Area District (NA 2) at the intersection of West 254th Street and Independence Avenue, seeking grant of authorizations for a modification of topographic features on a Tier II site and for modification of botanic environment and tree preservation and planting requirements to allow for site alterations to the existing one-family residence cited above.

- 2. West 254th Street is relatively narrow country-style road that leads to the Metro North Riverdale Station. Across the street from the Applicant's premises is the entrance gate to the Salanter Akiba Riverdale Academy ("SAR"), a school for pre-High School students. There are no sidewalks on either side of West 254th Street at or near the Applicant's premises, thereby forcing the numerous pedestrians walking to and from the Metro North Station and to SAR to walk in the street adjacent to the premises, assuming parked cars have not blocked that area. In sum, public safety concerns are already present.
- The application as presented on behalf of applicant by John Field of Building Studio reflected that Applicant proposed to create a vehicular parking area on the West 254th Street side of the premises opposite the gated entrance of SAR Academy, such parking area being in addition to the existing 5 or more parking spaces in and adjacent to the circular driveway in front of the Independence Avenue entrance of the premises. Specifically, public safety concerns were expressed by reason of the traffic that would be generated from the proposed West 254th Street parking area, both in terms of the safety of the students entering and leaving the school and pedestrians walking to and from the Riverdale Station of Metro North and passing directly in front of the entrance/exit of the parking area -there being no sidewalk at that point. Additionally, questions were presented respecting other aspects of the application and the shed positioned on the West 254th street side of the premises. Mr. Field acknowledged the concerns and said he would address them with his client. In view of concerns expressed at the meeting and to afford the applicant an opportunity to address those concerns prior to vote on the application, the application was by vote of the Land Use Committee laid over the next meeting of the Committee.
- 4. The January meeting of the Committee was cancelled on account of snow. At the next ensuing meeting of the Land Use Committee, held February 5, Mr. Field on behalf of the applicant agreed that the West 254th Street parking area presented a problem and represented that drawings or a rendering showing that the parking area would be removed from the application and a writing would be executed that it would not be restored and, instead, that a natural or other impediment would be erected completely precluding such vehicular ingress or egress on the West 254th Street side of the premises. Mr. Field also represented that the shed would be removed once the first permits issued and that the undertaking to secure such removal would be given in writing. Finally, Mr. Field represented that the foregoing writings would be submitted to the full Board at its February 13, 2018 meeting so that a vote could be taken by the full Board on the conditionally accepted application with the foregoing representations confirmed in writing.
- 5. None of the promised writings were delivered to the Board office prior to the February meeting (or at any time thereafter). In view of such non-compliance with the representations made the Land Use Committee, by vote of the Board the application was tabled. Neither the applicant nor any representative appeared at the February 13 meeting of the full Board.

- 6. On or about February 16, the applicant telephoned the Chair of Land Use and explained that Mr. Field was working on ways to comply with the foregoing representations and to comply in a fashion consistent with both the Natural Area District requirements and Landmarks regulations. The Chair advised the Applicant that the matter could be held until such reasonable time as Mr. Field could accomplish that goal consistent with the representations that had been made and that Applicant or Mr. Field should communicate with the Board office to advise when the corrective work on the application was complete and ready for review. The Applicant agreed.
- 7. The matter was calendared for the March 5 meeting of Land Use but was adjourned when it was reported that, the promised materials had not been filed with the Board office -- a possibility anticipated by the Applicant in the above-mentioned telephone conversation.
- 8. After the conclusion of the March Land Use meeting, the representative of the Department of City Planning, Juton Horstman, advised the Chair of the Board and the Chair of Land Use that the Application would, despite all of the foregoing, be presented to the full City Planning Commission for a vote on March 14, 2018. The effect thereof would be that the Board would not be heard prior to vote on the application by the City Planning Commission. In view thereof both the Chair of the Board and of Land Use asked Mr. Horstman to request a layover by the Commission. Thus far, no such layover has been indicated.
- 9. Based on the foregoing disclosure as to the projected City Planning Commission action on March 14, the Chair of Land Use notified both Mr. Field and the Applicant that the matter would be presented to the full Board at its regular meeting on March 13, 2018 and that it appeared to the Chair that a covert effort was being made to renege on important public safety commitments made by the Applicant's representative with the authority of the Applicant. The Applicant has since advised the Chair of Land Use that he intends to maintain ingress and egress from West 254th Street for use by his "landscapers";

NOW THEREFORE, upon discussion and due consideration by Community Board No.8 at its duly convened March 13, 2018 monthly Meeting;

BE IT RESOLVED, that in the interests of the public health, safety and welfare of the Community, as well under the circumstances recounted above, the foregoing Application is, **DENIED**.
