Chairman Fanuzzi called the meeting to order at 7:35 PM.

1. Gallery Session

- A. Tracy Shelton, discussed river access along the Hudson River and displayed post cards signed by supporters; urged support of the Riverfest event on June 15th, on the grounds of the College of Mount Saint Vincent. Referred to the supplement in the Riverdale Press "Riverdale Station Park Start of Something Spectacular." Amongst other information in the article, there is mention of river access through a tiny park through the Metro North West 254th Street Station. It is a beautiful little park with breathtaking views of the Hudson River. KRVC is committed to the expansion of this park to the north into Yonkers and to the south into Manhattan for a continuous riverfront greenway in this community that connects up and down the Hudson River.
- B. Frank Anelante, Chair, Spuyten Duyvil River Coalition, listed recommendations for the Board to consider in its Hudson River Greenway resolution for riverfront access relative to the NYMTC plan as follows: no cantilever on the Henry Hudson Bridge; streets should not be disturbed, but remain as they are; no widening streets to their mapped but unbuilt portions; and no reduction of traffic lanes or street parking on Riverdale Avenue, or anywhere else in Community Board 8; "Forever Wild" Riverdale Park should continue as such, totally undisturbed; no going through the Park, no constructing of mixed use bicycle paths, ramps, and/or bridges through either it or the Palisade Avenue right of way from Spaulding Lane to West 254th Street; access to the waterfront and link should be at West 254th Street only. Additionally, he asked that the Board continue community involvement with the process.
- C. Jorge Sierra, presented information on the Bronx LGBTQ Center, a New York State membership-based, not-for-profit corporation working to build a new community services center for LGBTQ and supportive individuals in the Bronx, lower Westchester, and upper Manhattan. It offers supportive services such as free legal clinics and workshops, youth and women's support groups, social and recreational events, arts and cultural programming, and support for businesses. The Center is partnering with other community-based organizations to provide clinical and health-related services to the community. The new Bronx LGBTQ Center will present its 2014 Bronx LGBTQ Pride & Health Fair on Saturday, July 19th from 12-6 PM at Crotona Park's amphitheater in the Bronx. This will mark the 2nd anniversary of a longstanding event organized under their leadership, with community support. Last year, nearly 2,000 attendees participated in an event that celebrated LGBTQ pride and equality. - D. Herb Barret described unsafe traffic conditions in the Kingsbridge section, mainly in the areas of Kingsbridge Avenue, West 231st and 232nd Streets. He strongly recommended the presence of a police officer at the corner.
 - Chairman directed Mr. Barret to confer with P.O. Cordero, 50th Precinct, Community Affairs, who was in attendance and to be in touch with the Traffic and Transportation Committee.
- 2. Approval of Board Meeting Minutes of May 13, 2014

- R. Ginty referred to the resolution regarding the funding contract with GrowNYC for youthmarkets, Page 5, after "Discussion ensued." She proposed the following language be added relative to comments made during discussion: "After several suggestions for further analysis by the Board or establishing a subcommittee at the beginning of the year or in the fall to review the practice and process for this contract and with the understanding that this will be done, the question was called."
- M. Wolpoff added his name to page 6, item 10, to reflect his member participation with the Community Service Awards presentations.
- M. Goodman corrected Libraries and Cultural Affairs Committee report, page 11, item 4, to reflect that the June 5th meeting location is at Van Cortlandt Branch Library.

The minutes were approved as amended by a vote of 39 in favor, 1 opposed - J. Pilsner and 1 abstention – P. Friedman.

3. Discussion of Executive Committee Meeting Minutes of June 4, 2014

Minutes will be adopted by the Executive Committee at its next meeting.

- 4. Chairman welcomed and invited P.O. Steve Cordero, 50th Precinct to address the Board.
 - P.O. Cordero reviewed the year to date crime statistics for the 50th Precinct: current year versus (vs) last year: murder 0 vs 1, rape 9 vs 0, robbery 59 vs 58, felony assault 55 vs 57, burglary 62 vs 61, grand larceny 162 vs 171, grand larceny auto 44 vs 42, transit 13 vs 4, housing 25 vs 18, and shooting victims 2 vs 5. The Greendot Moneypak card scam is still prominent with three incidents occurring within the 50th Precinct as recent as May. Chase Bank, 3775 Riverdale Avenue was target of a high tech ATM card skimming. Criminals place skimming devices at bank door entrance and ATM machine and pin numbers are being recorded. An information sheet for safeguarding against ATM skimming was passed out.
 - B. Bender conveyed thanks to D.I. Rasa for attending a meeting and discussing the situation with ATVs in Van Cortlandt Park.
- 5. Chairman welcomed Councilman Andrew Cohen and invited him to address the Board.

Councilman Cohen thanked Chairman Bob Fanuzzi and Bob Bender for joining him at the press conference held to announce the City Council Resolution 251 being brought by himself and colleagues Councilmen Mark Levine and Ydanis Rodriguez regarding the LG Tower. Councilman Cohen stated he has been at the City Council working on the City Budget.

6. Report from the Office of the Bronx Borough President – J. DeSio

Assemblyman Jeffrey Dinowitz and State Senator Jeff Klein were joined by Bronx Borough President Ruben Diaz Jr. and a host of community activists as well as Chairman Fanuzzi near the Jerome Park Reservoir to introduce new legislation intent on designating Jerome Park as parkland of the City of New York. The bills, A 9681 and S 7467, would set in motion a public process by which most or all of what is known as Jerome Park can either become designated as parklands or lands that can be readily

accessible to the general public for recreational use. The space could also be used as an urban wildlife or nature sanctuary.

7. Chairman's Report

• Applauded Councilman Andrew Cohen for the very acute Resolution 251, introduced to the City Council calling on the Borough of Englewood Cliffs, New Jersey to withdraw the variance issued to LG Corporation to allow its headquarters to exceed the 35 feet height limit for its tower along the Palisades. He spoke about Community Board 8 being the first to pass a resolution opposing the LG tower. Chairman then made a motion to add a resolution to the Agenda from the floor in support of Resolution 251. The motion was seconded. The resolution passed unanimously by a vote of 41 in favor, 0 opposed, and 0 abstentions:

Recognized B. Bender, who moved the following resolution from the floor:

Whereas, Councilmembers Andrew Cohen, Mark Levine, and Ydanis Rodriguez have introduced Resolution 251 in the City Council calling on the Borough of Englewood Cliffs, New Jersey, to withdraw the variance it issued to the LG Corporation that would allow LG to build its new headquarters to exceed the 35-foot height limit established in the Borough's zoning laws and previously respected by other builders in the Borough; and

Whereas, the LG Corporation to date has refused to lower the height of its proposed new headquarters from 143 feet, which would alter the view of the Palisades north of

Fort Lee, New Jersey, and set a dangerous precedent for future development along the Palisades; and

Whereas, the Palisades of the Hudson River are a National Historic Landmark and a National Natural Landmark and have been designated a National Treasure by the National Trust for Historic Preservation; and

Whereas, Bronx Community Board 8 in May 2013 unanimously passed a resolution urging the LG corporation to re-configure its headquarters to respect the historic status of the Palisades and calling on our elected officials to take appropriate action in support of that resolution;

Therefore Be It Resolved, that Bronx Community Board 8 supports Resolution 251 as introduced by Councilmembers Cohen, Levine, and Rodriguez, and thanks for them for taking action to help preserve the beauty and integrity of the Palisades.

- Reported on the April 2014 meeting of the Croton Water Filtration Plant Monitoring Committee. The Department of Environmental Protection (DEP) delayed a proposed limited public access plan for Jerome Park Reservoir until construction is completed on the east wall of the Reservoir. A proposal was made to DEP that in the event construction did not affect the Reservoir's entire perimeter that the public should be given provisional limited access, as proposed by CFMC. DEP has taken this under advisement. DEP is refusing to pay for restoration of trees taken down by DEP around Jerome Park Reservoir. To that end, Comptroller Stringer has written a letter to DEP Commissioner Lloyd inquiring about plans to replace the trees.
- Chairman extended great thanks to the Board office staff and District Manager for their hard work this past year and during his three year tenure. He especially thanked N. Stent for her counsel. He discussed his three year tenure and reviewed Board challenges and successes. He noted expansive economic growth along Broadway, enhanced street activities, creation of youth farmer's markets, new annual youth events which include Poetry Slams, Golf Day, Youth Ice Skating Day in Van Cortlandt Park, extensive land use matters with development, affordable housing, and more. In the area of Parks, there has been a development of a Master Plan for Van Cortlandt Park, and there has been much work and effort with proposed plans for the Hudson River Greenway and Putnam Trail.

8. Treasurer's Report

The report is submitted quarterly. Reviewed Board finances on May 29th and filed report with the Officers.

9. District Manager's Report – N. Stent

- The Board Office will once again be a drop-off site this year for Operation Backpack. Operation Backpack 2014 is sponsored through Volunteers of America-Greater New York to support homeless children. Last year 65,000 backpacks were collected. The backpacks can be dropped off starting July 1st through July 31st.
- N. Stent thanked Board office staff members Diane Bay and Patricia Manning for their performance with the work of the Board.

10. Report of the Nominating Committee – M. Wolpoff

M. Wolpoff wrote to the State Committee on Open Government to ask for a review of the Nominating Committee process and received their decision on June 9, 2014 which was distributed to the full Board in advance of the Board meeting. WHEREAS, the 2003 197-a Plan of Bronx Community Board 8 supports a Greenway along the Hudson River and enhanced riverfront access for the community;

WHEREAS, local elected officials support a Hudson River Greenway and riverfront access for the community;

WHEREAS, the New York Metropolitan Transportation Council (NYMTC), with funding provided in part by Senator Charles Schumer, presented to the Parks & Recreation Committee of Bronx Community Board 8 and most recently to a joint meeting of that committee and the Traffic & Transportation Committee, a conceptual study of a proposed Hudson River Greenway route connecting the Manhattan and Westchester portions of the Greenway, which includes a short-term inland route from the Henry Hudson Bridge to the city line at Riverdale Avenue and a long-term waterfront route from the Henry Hudson Bridge to Yonkers along the Hudson River;

WHEREAS, Metro-North has identified stabilization and bolstering of the embankment that protects the shoreline from flooding on its tracks as priorities on the Hudson Line through Riverdale;

WHEREAS, Metro-North has represented that Track 6 of the Hudson Line through Riverdale is necessary for its operations, the stabilization and bolstering of the embankment on the shoreline and to accommodate anticipated growth in ridership in present routes and possible Penn Station access on the Hudson Line in the future;

THEREFORE, BE IT RESOLVED THAT:

- 1. This resolution supersedes the May 2012 resolution of Bronx Community Board 8 regarding the Hudson River Greenway.
- 2. Bronx Community Board 8 supports an all-river Hudson River Greenway.
- Bronx Community Board 8 rejects the NYMTC proposal to widen streets
 to their un-built width, remove trees, reduce traffic and/or parking lanes on
 local streets, construct a cantilever mixed-use attachment to the Henry

- 6. That engineering and other feasibility studies be performed by the appropriate agencies to evaluate the connection of the Hudson River Greenway from Manhattan to the Bronx across the Harlem River at Spuyten Duyvil, via the Amtrak swing bridge or on a new purpose-built swing bridge.

That initial access to the Greenway be implemented by using either of the existing bridges to cross the Metro-North tracks at West 254th Street or the Riverdale train station overpass and that the first segment of the Greenway be constructed on the west side of the Metro-North tracks from West 254th Street to Yonkers while other access points to the Greenway are investigated.

 The Committee passed a resolution on the Street Naming for former Board Member Debbie Bowden. D. Padernacht yielded presentation of the resolution to Education Committee Chair S. Alexander. 4. S. Alexander presented the following resolution:

WHEREAS, Debbie Bowden died on January 30, 2012, and this resolution is brought more than two years after her death;

WHEREAS, Debbie Bowden has been nominated for the honor of this proposed street change by the Riverdale Neighborhood House, The Riverdale Community Center and The Bayit Hebrew Institute of Riverdale, which are three community organizations that are active in Bronx Community Board 8 and as such, are on the list required to be kept by Bronx Community Board No. 8 under the new City Charter;

WHEREAS, the evidence and testimony presented to Bronx Community Board No. 8 has demonstrated that Debbie Bowden has benefited a cross-section of Bronx Community Board No. 8 and the Borough of the Bronx and the City of New York;

Specifically, Debbie Bowden served on Bronx Community Board No. 8 for 25 years and 17 years of that time she served as chair of the Education Committee. Debbie was involved in the fight to keep housing off the empty land directly in front of JFK High School. She was involved in organizing an all-night vigil at City Hall to participate in the fight against Mayor Koch's desire for the housing instead of the Educational Park it was intended to become. Later, MS/HS 368 and PS37 were built there to complete the Educational Park.

Debbie lobbied against the reduction of NY Public Libraries cuts of hours which many Mayors put in their proposed budgets and the City Council usually restored. She was determined that it was very important for students to have adequate access to libraries to be able to do research and school projects. This was before computers were available.

Debbie led the fight to retrieve the annex for PS24 after DOE allowed "out of district" schools to use it, creating overcrowding in the main building.

Debbie was a member of a community committee to fight for the creation of the high school at JHS 141 which was later named Riverdale/Kingsbridge Academy.

In the interim, she served as co-chair of the Parents Association at PS 24. She brought about many new programs for the students at the school. She brought about hiring a reading teacher from PA funds to be a resource and offer remediation for students. She also brought about a dance program from PA funding which enabled students to pursue future careers in the arts.

WHEREAS, this street has a specific connection to the life of Debbie Bowden as it is the street in front of P.S. 24;

WHEREAS, the name change will not engender confusion as there are no other streets with similar name in the vicinity;

THEREFORE, BE IT RESOLVED, that Independence Avenue between West 235th Street and West 236th Street shall be renamed to add the name Debbie Bowden Way.
