# **Special Notice about ZQA and MIH**

We have just learned that the City Council has scheduled public hearings for February 9 and February 10 regarding Zoning for Quality and Affordability ("ZQA") and Mandatory Inclusionary Housing ("MIH") text changes. The City Planning Commission has not yet voted on its reports on the zoning text changes. Amendments are expected. We anticipate adoption on February 3.

Community Board 8 unanimously rejected both zoning text changes on November 10. The Board Office will provide the CPC reports on ZQA and MIH, once received, via email to any member of the public who requests a copy.

Because both of these are important actions with significant impacts for our community, the Land Use Committee of the Community Board will hold a public hearing on February 4 at the Horace Mann School, 231 West 246 Street at 7:30PM. The hearing will focus on any changes made by the City Planning Commission. The City Council hearings for February 9 and February 10 will be held in the Council Chamber, City Hall at 9:30AM.

On January 1, 2016, the New York City's Commuter Benefits Law took effect. This law requires employers, both for-profit and nonprofit, with 20 or more full-time employees to allow for their employees to use pre-tax income to buy eligible transportation fringe benefits. ### Emergency Snow Laborers Needed

The Department of Sanitation is hiring snow laborers for the snow season. Snow laborers are Per-diem workers who are called upon to remove snow and ice throughout the city; from bus stops, crosswalks, fire hydrants and step streets in the after heavy snowfalls.

Individuals interested in registering with the DSNY can do so at their local district garage weekdays between 7:00AM and 3:00PM. The list of garage locations can be found at www.nyc.gov/sanitation. Laborers will be paid \$13.50 per hour, and \$20.25 per hour after 40 hours are worked in a week.
