John Weed Bronx Works

1. Minutes of previous meeting, November 22nd, 2011 approved as submitted.

2. Speaker, John Weed of Bronx Works: established in 1972, it is a nonprofit social service agency with twenty-five sites serving people of all ages with 600 employees. Recently it was funded by Department For the Aging (DFTA) as an "innovative" senior program site, one of eight funded. New services include wellness, gardening, expansion to evening meals during daylight savings time and some Saturdays. There is a new gymnasium, planned farmers' market, elder abuse program. Minor repairs for seniors, i.e. light bulb changing, are available through a foundation grant. Bronx Works has a contract to assist seniors in housing court since many face eviction. There is a geriatric mental health program, ESL and an immigration attorney. Location is at Morris and 181st street. All Bronx Works senior centers are in Bronx Community Board 5. Participants are 80% Latino, 60-85 years of age. Bronx Works needs to increase number of participants' participation in programs to demonstrate its success. Participants don't need to utilize meal program.

Suggested were an intergenerational program for gardening and joining in a competition with Riverdale Senior Services on Wi games.
