- 1. Meeting called to order at 7:10 PM

- 3. Legislative Review

There was discussion concerning new intros brought to the City Council. Most discussion focused on items concerning proposed legislation in support of the ride share industry, e.g. Zip Cars. The intros sought to reserve street parking spots and a percentage of parking spots within City-owned properties. It was unknown if there would be any impact on parking associated with the New York City Housing Authority. The committee could not understand the deference to a profit-making enterprise when such deference has never been offered to other rent-a-cars.

4. Items from COIB

The committee discussed a recent Conflicts of Interest Board disposition concerning a Brooklyn community board member who chaired a committee dealing with an item concerning the City agency for which he was employee. The board member was fined.

5. Bylaws review

Over a period of several months there has been a request that the bylaws contain a section on "Penalties." The committee felt that Article III Section4 was sufficient. The only issue was to identify a working definition for :"good cause"*

6. Ethical Guidance Manual

- a. The committee re-reviewed the item concerning honoraria as presented in the Ethical Guidance Manual (EGM). It was reaffirmed that the EGM was focused on board members. Thus, there would be no recommendation to change the verbiage.
- b. A board member suggested a clarification on the verbiage concerning conflicts of interest. Thus, it was recommended that Article II, Section 1 be amended to add the phrase, "they may no vote on <u>any resolution for which they have a conflict."</u>
- c. A malapropism was found. Thus in Article V, Section 3 would be modified to correct the spelling.

7. Civics project

There has been no further information from the Kingsbridge library branch concerning an invitation to offer a presentation on civics.
