Minutes for the Public Safety Committee Meeting

Andrew Sandler reported on the status of the North Riverdale owner's six dogs. The Dept of Buildings cited her for a fence surrounding her property that is not tall enough to meet the code. This resulted in the dog's ability to leave the property and harm neighbors. The dogs have been removed and placed in an animal hospital until the fence is replaced. Andrew reported that she has applied for a permit to build a higher fence.

Chairs Report:

Board continues to monitor issues: Plans to consolidate mail distribution center in the Bronx; dog removal on Riverdale Avenue; imposters posing as Con Ed employees.

At suggestion of Sergio Marquez, the chair checked with ethics board and confirmed that the board is in fact allowed to give Detective Rodriguez and his wife a gift to welcome their new twins, under the "one-time special personal occasion" exclusion to dollar limits rule. Gift will be presented at the April board meeting.

The Police Dept report was read by the Chairwoman. Comparing the statistics from last year to date:

The Committee unanimously adopted a resolution approving the five (5) applications for those that had representatives present and tabling the eight (8) that had no representatives at the Committee.

A resident of Irwin Avenue sent a letter to the Board and appeared before the Committee concerning requests for stop signs at various locations in Kingsbridge and for enforcement of regulations in certain other locations. He also appeared before the Traffic and Transportation Committee. There was a consensus that the issue be coordinated with the T & T Committee and a request be sent to the 50th Precinct to research the history of accidents, etc at the locations requested for enforcement.

The Chair read a list of budget requests from the Fire Department:

- Renovation funds have been cut by 30%. They ask for capital funding in this category.
- Fire Safety Education expense budget funding.
- EMS Gators they request capital funding to replace 6 of the fleet of 10.
- They request expense money for CPR kits.

A committee member requested that Manhattan College be contacted to share their required safety plan for their educational research nuclear reactor.

The meeting was adjourned at 8:15.
