The meeting came to order at 7:38pm

- 1. NYC DOT PROPOSAL TO INSTALL ENHANCED CROSSWALKS AT THE FOLLOWING INTERSECTIONS: W 235TH ST AND OXFORD AVE, W 235TH ST AND CAMBRIDGE AVE, W 238TH ST AND WALDO AVE, W 238TH ST AND IRWIN AVE
- DOT gave a presentation describing the enhanced crosswalks at the 4 locations.
- Enhanced crosswalks will have a 15 foot parked car clearance on each side and white striping. They will also be ADA compliant curb cuts and have Pedestrian X-ing signage.
- Cars are required to stop for crossing pedestrians in a crosswalk.

- Discussed the qualifications for a STOP sign and installing the enhanced crosswalks does not exclude this location from a future All-Way-Stop.
- Scheduled to begin in Summer 2018.

2. TRAFFIC CHANGES ON MOSHOLU PKWY

NYC DOT Bronx Commissioner Lopez gave an informational-only presentation about traffic intersection changes on Mosholu Parkway. Chair Padernacht explained that this area is just outside of Community Board 8 but that many of our residents use this roadway.

- DOT will add a second northbound lane on Mosholu Avenue between Paul Avenue and Gun Hill Road.
- DOT will make the turning lanes to Sedgewick Avenue safer.
- Scheduled to begin in Summer 2018.

3. RESIDENT REQUEST FOR CROSSWALK AT WEST 237TH AND HUDSON MANOR TERRACE

- Neighborhood resident Nina Huberman gave a presentation on why a crosswalk is needed at the intersection of W. 237th and Hudson Manor Terrace.
- Cars are allowed to park at this T-intersection which blocks the ADA curb cut. Residents in the area with wheelchairs and strollers are unable to cross the street.
- Several residents from the area spoke in favor.

Chair Padernacht put forth the following resolution:

WHEREAS, testimony has been presented to the Traffic and Transportation Committee of Bronx Community Board 8 regarding safety concerns on West 237th Street and Hudson Manor Terrace; and

WHEREAS, testimony has been presented that a curb cut is located at the northwest corner of this intersection which is a "T" intersection in which cars may park in front of the curb cut; and

WHEREAS, there are two public schools and two religious institutions within close proximity of this intersection; and

WHEREAS, testimony has been presented from community residents who support the installation of a crosswalk at this intersection;

BE IT RESOLVED, that the Traffic & Transportation Committee of Bronx Community Board No. 8 requests that the NYC Department of Transportation study the intersection at West 237th Street and Hudson Manor Terrace to determine if a crosswalk can be installed at this location.
