1. NYC DOT proposal to install enhanced crosswalks at the following intersections:

- W 235<sup>th</sup> St and Oxford Ave
- W 235<sup>th</sup> St and Cambridge Ave
- W 238<sup>th</sup> St and Waldo Ave
- W 238<sup>th</sup> St and Irwin Ave

An enhanced crosswalk is one which does not have a traffic control device such as a stop sign or traffic light. Instead, parking spots are removed before the crosswalk in order to increase visibility of persons in the crosswalk.
