

EXTENSION AGREEMENT, effective July 1, 2013 between the City of New York ("City"), acting by and through the Department of Information Technology and Telecommunications ("DoITT" or "Department") with offices, located at 255 Greenwich Street, 9<sup>th</sup> Floor, New York, NY 10007 and Comsys Information Technology Services, LLC ("Contractor"), with offices located at 245 Fifth Ave. - 3rd Floor, NYC, NY 10016.

WITNESSETH

WHEREAS, the parties entered into an agreement for the Contractor to provide Citywide Standby Information Technology and Telecommunication Consulting Services for the term of April 14, 2011 through April 13, 2014 pursuant to the New York State Office of General Services ("NYS OGS") Group: 73012, Award: S960275-E.1, hereinafter referred to as the "Back-Drop Contract";

WHEREAS, the Back-Drop contract term ended on December 31, 2011 and the NYS OGS did not renew the contract;

WHEREAS, In order to provide uninterrupted services utilized Citywide, DoITT entered into a Negotiated Acquisition Extension agreement with the Contractor for the term of January 1, 2012 through June 30, 2013 under the (hereinafter referred to as the "Agreement"); and

WHEREAS, pursuant Section 3-04 of the Procurement Policy Board Rules, the parties desire to extend the Agreement to June 30, 2014;

NOW THEREFORE, the parties agree to as follows:

1. Except as modified herein all of the terms, conditions and covenants of the Agreement shall remain in full force and effect and are specifically incorporated herein as Exhibit A (Contract # 858-20126200526) attached hereto.
2. The Agreement is hereby extended for the period of July 1, 2013 to June 30, 2014.
3. During the negotiated acquisition extension period of July 1, 2013 to June 30, 2014, the Contractor shall be paid an amount not to exceed \$9,000,000 to provide Citywide Standby IT and Telecommunication Consulting Services telecommunication services.
4. This Extension Agreement shall not become effective or binding unless:
  - A. Authorized by the Mayor; approved pursuant to the New York City Charter and Procurement Policy Board Rules for contracts not subject to public letting; and the Comptroller shall have endorsed his or her certificate that there remains unexpended and unapplied a balance of the appropriation of funds applicable hereto sufficient to pay the estimated expense of executing this Extension Agreement; and
  - B. Approved by the Mayor pursuant to the provisions of Executive Order No. 42, dated October 9, 1975 in the event the Executive Order requires such approval; and

- C. Certified by the Mayor (Mayor's Fiscal Committee created pursuant to Executive Order No. 43, dated October 14, 1975) that performance thereof will be in accordance with the City's financial plan.
- D. The requirements of this Article shall be in addition to, and not in lieu of, any approval or authorization otherwise required for this Extension Agreement to be effective and for the expenditure of City funds.
