<b>Job Description</b>	
<p>The New York City Conflicts of Interest Board is seeking a Deputy General Counsel to work in its Legal Advice Unit. The Board is an independent City agency and is responsible for administering and enforcing the City's conflicts of interest, annual disclosure, and lobbyist gift laws. (See the Board's website at <a href="http://nyc.gov/ethics">http://nyc.gov/ethics</a>.) The Deputy General Counsel reports to the General Counsel. With the General Counsel, the Deputy General Counsel will be responsible for directing the advice-giving work of the agency, that is, assisting the Board in fulfilling its City Charter mandate of providing advice regarding compliance with the City's conflicts of interest law, lobbyist gift law, and regulation of not-for-profits affiliated with City elected officials and their agents. The successful candidate will conduct legal research, draft advisory opinions, staff letters, and memoranda to the Board, provide oral advice to City employees, conduct training sessions, and with the General Counsel supervise the other attorneys in the Board's Legal Advice Unit in performing these functions.</p>	
<b>Minimum Qualification Requirements</b>	
<p>Admission to the New York State Bar; and four years of recent full-time responsible, relevant, satisfactory legal experience subsequent to admission to any bar, eighteen months of which must have been in the supervision of other attorneys, in an administrative, managerial or executive capacity, or performing highly complex and significant legal work.</p> <p>Incumbents must remain Members of the New York State Bar in good standing for the duration of this employment.</p>	
<b>Preferred Skills</b>	
<p>The successful candidate must possess the maturity, discretion, and judgment necessary for the handling of a myriad of sensitive, and often confidential, matters, and the advising of public servants at all levels, including senior elected and appointed officials. Strong writing and analytical skills are also required, as is a temperament suitable to work in and help lead a small, collegial law office. Prior government experience as well as experience with web-based applications are also preferred.</p>	
<b>Residency Requirement</b>	
<p>New York City residency is generally required within 90 days of appointment. However, City employees in certain titles who have worked for the City for 2 continuous years may also be eligible to reside in Nassau, Suffolk, Putnam, Westchester, Rockland, or Orange County.
