		<p><u>Presentation</u></p> <p><i>The Manhattan Grid</i>; presented by Hilary Ballon, Deputy Vice Chancellor, NYU Abu Dhabi; University of Urban Studies and Architecture, NYU. The grid was not the pre-ordained condition of Manhattan. It took bold decision-making, a transformation of city government and ideas about the public realm, and sustained commitment over many generations to realize the Commissioners Plan of 1811. Drawing on historical maps and photographs from <i>The Greatest Grid: The Master Plan of Manhattan, 1811-2011</i>, the exhibition at the Museum of the City of New York, curator Hilary Ballon will reconstruct the challenges the Commissioners faced and how their plan was implemented and altered over two centuries.</p>
