Job Description

Working in the Eastern Operations Division, Cat/Del Ultraviolet (UV) Facility, the selected candidate will be responsible for operating and maintaining daily distribution and UV treatment of more than 90% of New York City's water supply. The Cat/Del UV Plant is vital to New York City's water supply for both flow control and UV treatment of the Catskill and Delaware Aqueducts. The candidate will operate, maintain, repair, and inspect the UV treatment facility, including equipment, lands in the watershed areas, reservoirs, aqueducts and related systems of New York City; maintain logs of operations, equipment performance, maintenance and water quality; provide reports, perform calculations and tests, maintain records and keep inventory of chemicals, materials and equipment necessary for water treatment and maintenance of equipment; maintain quality standards and water quality parameters; maintain operations for compliance with mandates and deliverables under the Safe Water Treatment Act and Filtration Avoidance, including preparing written programs that comply with such mandates; operate motor vehicles, motor powered equipment and perform related work; and comply with all environmental health and safety laws, agency policies, rules and regulations.

Qualification Requirements

A four-year high school diploma or its educational equivalent and one of the following:

One year of full-time satisfactory experience in the operation and maintenance of equipment used in the controlling or purification of water at facilities in watershed areas, reservoirs, or aqueduct systems; *or*

Two years of full-time satisfactory experience as: a mechanic, journeyman or helper in the electrical, mechanical or construction trades; or as a technician in a chemical processing facility or chemical or water quality laboratory.
