## REQUIREMENTS TO BECOME AN APPROVED NOISE CONSULTANT

Pursuant to Section 24-231 of the Administrative Code and Chapters 29 and 32 of Title 15 of the Rules of the City of New York, the Department of Environmental Protection ("DEP") has established the following minimal requirements to become an approved noise consultant.

- A licensed New York State professional engineer possessing at least two years of experience measuring sound levels utilizing the ANSI standards. At least one year of such experience shall have been performed within the City of New York, and such experience shall include developing or proposing sound mitigation measures for buildings and noise-producing equipment or
- 2. A person possessing a Bachelor of Science degree or a Bachelor of Engineering degree from an accredited college or university with at least four years of experience measuring sound levels utilizing the ANSI standards. Two of such four years of experience shall have been performed within the City of New York, and such experience shall include developing or proposing sound mitigation measures for buildings and noise-producing equipment or
- 3. A person possessing ten years of experience measuring sound levels utilizing the ANSI standards. Five years of such experience shall have been performed within the City of New York, and such experience shall include developing or proposing sound mitigation measures for buildings and noise-producing equipment.

A person is eligible to appear on such list if he/she has submitted to DEP a description of the required experience, qualifications, and references, in sufficient detail, to demonstrate that he/she meet one or more of these requirements, request that their name be included on such list and DEP concludes that the submission satisfies the relevant requirement.
