**PHOTOLUMINESCENT EXIT PATH MARKINGS COMPLIANCE  
E-Class Occupancy Buildings  $\geq$  75 Feet in Height**

**Attention Owner/Agent:**

Local Law 26/04 requires that all high-rise office buildings (equal to or above 75 feet in height), E-Class occupancy group, install Photoluminescent Exit Path Markings **on or before July 1, 2006**. The markings and signs are in addition to and not in place of existing requirements relating to exit signs.

The Department of Buildings (Buildings) urges you to submit the required affidavit, Form LL 26/04-1, certifying compliance that Photoluminescent Exit Path Markings have been installed in your building. The form must also indicate the Material and Equipment Acceptance (MEA) number for each product used in the installation of these markings.

To avoid receiving violations for failing to install Photoluminescent Exit Path Markings, Buildings recommends immediately installing approved markings and submitting the required documentation (Form LL 26/04-1) certifying compliance with this law.

If you received a letter for non-compliance of this law in the mail and your building is not a high-rise E-occupancy office building and/or you are not the owner/agent for the building, please complete the attached Photoluminescent Statement of Non-applicability form. The form must be returned to the Local Law Enforcement Unit at 280 Broadway, 4<sup>th</sup> Floor, New York, 10007.
