#### **Demolition Filing Process Begins in Borough Offices**



The Buildings Department is changing its demolition filing process to standardize it agencywide. Beginning October 30th, you must visit the Borough Office where the property is located to pre-file your demolition job before submitting documentation to the Building Enforcement Safety Team (BEST). Also beginning October 30th, additional required documentation for demolition jobs (B Form 2A or BEST-4) can be e-mailed directly to BEST. View the service notice (34 kb-pdf) for more information.
