Buildings Department Combats Illegal Advertising Signs



A new enforcement campaign was launched on January 9, 2007, to combat illegal advertising signs posted on sidewalk sheds. As part of the pilot program, the Buildings Department will cover illegal advertising signs that building owners have failed to remove after notification and warning. New ED-16A Form for Licensed Electricians

To comply with recent amendments to the Electrical Code, a new ED-16A form for filing all types of electrical work, including the removal of violations, was launched on January 2, 2007. To make it easier for users, the new ED-16A no longer requires the owner's signature. However, where an owner's authorization is required by the Electrical Code, the Licensed Electrician must certify that he or she has the authorization in writing and that it will be available to the Department upon request. The new ED-16A form should only be filed by licensed electricians.

Supported Scaffold Law - Local Law 52

We've updated our Local Law 52 fact sheet (25 kb pdf) and training provider list (22 kb-pdf)! Local Law 52 ensures safe and compliant construction throughout all five boroughs, by requiring a permit for all supported scaffolds 40 feet or higher. In addition, Local Law 52 of 2005 requires individuals who use, erect, maintain, dismantle, repair or modify a supported scaffold to have a certificate of completion in a scaffold safety program.
