### Model Code Team Reaches Milestone

The Model Code Team has been hard at work drafting the chapters of the new NYC Construction Codes and recently reached the halfway mark of drafting the new codes, with over 30 chapters drafted. These final <u>draft chapters</u> and appendices are available online for you to review as the team prepares the final submission for the City Council. In addition, each new chapter is accompanied by an easy-toread "Section by Section" summary of key changes from the current code. Not far behind, the rest of the drafted chapters will be posted online throughout the month of March. Going forward, the Model Code Team will continue its outreach efforts to local professional groups to ensure a smooth transition for all.

### New Automated Required Item for Sidewalk Sheds

Effective March 19th, to ensure proper lighting on all sidewalk sheds, <u>BISWeb</u> will automatically require proof of an associated electrical permit or electrical job number for all sidewalk shed applications. View the <u>service announcement</u> (23 kb-pdf) for more information.

### Did You Know?

Did you know that you can check <u>BISWeb</u> to determine whether a Stop Work Order (SWO) is active on a property? Following the issuance of a permit and prior to beginning any work, you should always check BISWeb to determine whether a SWO is active on the premises. To discuss how to lift a SWO, contact the <u>Construction Unit</u> in your local <u>borough office</u>. If any work is performed in violation of an active SWO on the premises, both the owner and contractors may be subject to additional <u>violations and fines</u> (44 kb-pdf) that carry a legislated minimum penalty of \$2,000.
