### Buildings Responds to Lexington Avenue Building Collapse

Buildings Commissioner [Patricia J. Lancaster](#) and the Forensic Engineering Unit evaluated a partial [building collapse](#) at 1861 Lexington Avenue on March 27, 2007. While the cause of the collapse is still under investigation, preliminary reports suggest interior construction work being performed at the time of the collapse may have compromised the structural integrity of the building. Buildings has ordered an immediate demolition and will continue to remain on site to oversee the demolition work.
